#### STATE BOARD OF DENTAL EXAMINERS

SUBJECT: Article XI; Dental Hygienists Functions

**<u>DESCRIPTION</u>**: This eliminates the function of application of fissure sealants as being exclusively performed by dental hygienists. These may be delegated by the treating dentist to other dental personnel, not just dental hygienists, if this amendment is adopted.

Section A.2.b provides a new regulation to govern dental hygienists utilizing lasers and that they must complete an education course involving lasers prior to performing any treatment on a patient.

**PUBLIC COMMENT:** A public hearing was held on January 20, 2012, and the public comment period expired on that date.

The following people commented that they had some problems with the proposed regulation because dental assistants could not place pit and fissure sealants. It was explained to each of the following individuals that, in the immediate future, there would probably be an amendment to the dental assistant regulation setting up a training program, for them to be able to place pit and fissure sealants. The following individuals expressed the same concern: (a) Rhonda Sledge of the Dental Hygienists Association; (b) Susan Long, UAMS Dental Hygienist School; (c) Bill Tarpley, Arkansas Dental Association; and (d) a representative from the Dental Association.

There were a number of individuals that wanted to express opinions about the use of lasers, but no one was against the proposed rule as it involved lasers and the training of dental hygienists to use lasers.

An attorney with the Bureau of Legislative Research asked the following question: The stated purpose of the rule is to eliminate the function of application of fissure sealants as being exclusively performed by dental hygienists as it may also be delegated by the treating dentist to other dental personnel. What other dental personnel would be applying the sealants? Dental assistants and dentists? I'm assuming that all dental personnel would be trained and licensed, right? **RESPONSE:** Yes, this rule change would also allow dental assistants to perform these functions. They would be trained and licensed.

The proposed effective date is February 1, 2013.

**CONTROVERSY:** This is not expected to be controversial.

**FINANCIAL IMPACT:** There is no financial impact.

**LEGAL AUTHORIZATION:** The State Board of Dental Examiners shall by rule or regulation "prescribe those acts, services, procedures, and practices which may be performed by dental hygienists and dental assistants at the direction and under the direct supervision of a licensed dentist and shall impose requirements and restrictions on the performance thereof by dental hygienists and dental assistants as it shall deem proper and

necessary to protect and promote the public health and welfare of the citizens of this state." Ark. Code Ann. § 17-82-208(c).

## ANALGESIA, CONSCIOUS SEDATION, DEEP SEDATION, AND GENERAL ANESTHESIA RULES FOR A DENTIST IN AN AMBULATORY FACILITY

#### A. DEFINITIONS

- 1. Analgesia The diminution of pain or production of increased tolerance to pain in the conscious patient.
- 2. Anesthesia Partial or complete loss of sensation with or without the loss of consciousness.
- 3. Anesthesia Period The period of time beginning with the placement of a needle, mask, or solution into or onto the body until the patient has met the criteria which are appropriate for dismissal.
