21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code Title 20, Chapter 31, Subchapter 1 is amended
24	to add additional sections to read as follows:
25	20-31-106. Permits to conduct construction, installation, or
26	maintenance of electrical work Inspections.
27	(a)(1) The owner or authorized agent of the owner of a property upon
28	which the construction, installation, or maintenance of electrical work will
29	occur shall obtain a permit for the construction, installation, or
30	maintenance of electrical work from the county or municipality in which the
31	property is located in a manner determined by ordinances of the county or
32	<u>municipality.</u>
33	(2) An authorized agent under subdivision (a)(l) of this section
34	may include a:

1	(A) Master electrician under \$ 17-28-101 constructing,
2	installing, or performing maintenance upon electrical work on the property;
3	<u>and</u>
4	(B) Residential building contractor under § 17-25-502 if
5	the project is a single family dwelling.
6	(3)(A) Except as provided in subdivision (a)(3)(B) of this
7	section, the permit shall be obtained before the commencement of the
8	construction, installation, or maintenance of electrical work.
9	(B) If construction, installation, or maintenance of
LO	electrical work must be performed in an emergency situation, the application
L 1	for a permit shall be submitted within one (1) business day of the

13	(4)(A) A county or municipality may charge a reasonable fee for

L5	(B) The amount of the fee shall be established by

34	work satisfies the statewide standards for the construction, installation,
35	and maintenance of electrical facilities and the performance of electrical

1	(2)(A) Electricity shall not be transmitted through any
2	electrical work for which a permit was obtained under subdivision (a)(1) of
3	this section until the completion of a final inspection by the authority
4	issuing the permit for the construction, installation, or maintenance of
5	electrical work.
6	(B) If the person conducting the inspection indicates the
7	work satisfies the statewide standards for the construction, installation,
8	and maintenance of electrical facilities and the performance of electrical
9	work under § 20-31-104, electricity may be transmitted through the electrical
10	work.
11	(3) If a person conducting an inspection under subdivisions
12	(b)(1) and (b)(2) of this section notes a deficiency in the electrical work,
13	the deficiency shall be corrected and a re-inspection shall be requested.
14	(4) An electrical inspection under this section shall be
15	performed by a county or municipal electrical inspector.
16	(5) A county or municipality that requires any type of
17	construction inspection shall require the inspections to include an
18	electrical inspection performed by a county or municipal electrical
19	inspector.
20	(c) This section shall not abridge the authority of the Department of
21	Labor.

23	20-31-107. Installation or activation of electrical meters.
24	An electrical utility company shall not install or activate an
25	electrical meter without first obtaining the approval of the county or
26	municipality in which the property is located in a manner determined by
27	ordinances of the county or municipality.
