TO CREATE THE ARKANSAS VETERANS' HOME TASK FORCE - Act 38 (SB 3)

Task: Create the Arkansas Veterans' Home Task Force to study issues related to opening a new Arkansas Veterans' Home and develop specific recommendations for the General Assembly.

Mission: Specifically, the Task Force is to conduct a needs assessment to evaluate number of current and future Arkansas veterans in need of such a facility and the extent of services; to evaluate potential locations using either existing facilities or new construction; and to evaluate the cost an methods to pay for the facility. To begin meeting May 1, and monthly thereafter, until presenting a report of findings on or before October 31, 2013. Based upon the Emergency Clause the act was effective on signing.
