<u>HB1623</u>	J. Moore	TO EXEMPT H-2A VISA PROGRAM PARTICIPANTS WHO HAVE A VALID INTERNATIONAL DRIVER'S LICENSE OR PERMIT FROM THE SKILLS PORTION OF THE DRIVER'S LICENSE EXAMINATION.
