HB2112	Post	TO REQUIRE LICENSE PLATES TO BE DISPLAYED ON THE REAR OF DUMP TRUCKS AND PROHIBIT SIGNS THAT PURPORT TO DISCLAIM LIABILITY FOR DAMAGE CAUSED FROM THE LOAD CARRIED BY THE DUMP TRUCK.
HB2121	Eubanks	TO AMEND THE LAW CONCERNING SIGNS ON OR ALONGSIDE STATE HIGHWAYS, COUNTY ROADS, AND CITY STREETS.
HB2156	King	TO AMEND THE LAW RELATED TO TEMPORARY TAGS ISSUED TO THE PURCHASERS OF MOTOR VEHICLES.
HB2177	J. Edwards	TO ENHANCE SAFE PASSENGER TRANSPORTATION.
HB2008	Hubbard	TO REQUIRE A MOTOR VEHICLE TO BE IMPOUNDED IF THE DRIVER AND THE VEHICLE ARE IN VIOLATION OF THE MINIMUM LIABILITY INSURANCE REQUIREMENTS.
