10	WHEREAS, overcrowding in county jails is an ongoing problem in the
11	criminal justice system, with more persons sentenced to the Division of
12	Correction than the division is able to house at one time; and
13	
14	WHEREAS, county jails are reimbursed at approximately thirty dollars
15	(\$30.00) per day to house a person awaiting transport to the division, but
16	this amount is inadequate to fully compensate a county jail for the costs
17	associated with housing that person; and
18	
19	WHEREAS, housing a person awaiting transport to the division reduces
20	the ability of a county jail to hold other persons sentenced to incarceration
21	in a county jail for misdemeanor offenses or violations, as well as the
22	ability of a county jail to house arrested persons; and
23	
24	WHEREAS, the Committee on City, County, and Local Affairs is requested
25	to study the population of inmates being housed in county jails, the costs of
26	inmates' being held in county jails, the reimbursement rate available to
27	county jails, the reasons behind overcrowding in county jails, and possible
28	alternatives to address the problem of overcrowding in county jails,
29	
30	NOW THEREFORE,
31	BE IT PROPOSED BY THE HOUSE COMMITTEE ON CITY, COUNTY, AND LOCAL AFFAIRS OF
32	THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

34	THAT the House Committee on City, County, and Local Affairs study the
35	population of inmates being housed in county jails, the cost of inmates'
36	being held in county jails, the reimbursement rate available to county jails.
