

Arkansas Rural Connect (ARC) Broadband Grant Program



Arkansas Rural Connect: Overview

- Distribute up to \$119 million (additional \$6 million for costs of administration) to bring high speed internet (25/3 Mbps or faster) to project areas
 - ▶ \$5.7 million was allocated from the Restricted Reserve Fund last year
 - \$119 million was allocated from federal coronavirus relief (CARES Act)
 - CARES Act funds must be fully spent by the end of December 2020
- Applications will be scored and awarded on ongoing basis
- Applications can be reviewed until all funds are awarded
- Local authorities support a plan of development by co-applying with providers


Broadband Mapping Tool

New Opportunities For Arkansas Rural Connect Applicants:

- There is now \$100M in CARES Act funding available for broadband deployment to qualified areas before December 30, 2020.
- Internet Service Providers (ISP's) and Electric Cooperatives and their subsidiaries may now apply.
- Other companies capable of deploying broadband are also allowed to apply.
- Communities under 500 in population may now apply
- ISP's and Electric Cooperatives do not have to deploy to the entire community due to flexibility in the deployment rate.
- ISP's and Electric Cooperatives must include the area they plan to cover in their application.
- Applicants must include a letter with their application explaining how deployment will assist with telemedicine, distance learning, and telework.







Home > Survey Results Map
