MEETING SUMMARY

Review of Statutorily Required Reports

Presenter:

Dr. Charles Stein, Director, Division of Public School Academic Facilities and Transportation, was recognized. Dr. Stein presented two reports. Dr. Stein first discussed the annual report, *State of Condition of Academic Facilities Statewide*, indicating that \$2.75 billion has been spent on projects over the past nine (9) years to satisfy the state's school facilities needs. He commented that progress is being made to address these needs. Dr. Stein next discussed the biennial report, *Academic Facilities Master Plan Program – State Plan*, indicating that tables on pages 6-23 show listings of all projects for which school districts have submitted Master Plans. He stated these plans have been submitted but not all have been approved.

Discussion of Facilities Issues Related to Educational Adequacy

Presenter:

Ms. Nell Smith, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith provided information about facilities as it pertains to the educational Adequacy Study. She stated that as part of the state's responsibilities to provide an adequate education, the Education Committees are required to study the entire spectrum of education every two years; this is done through the Adequacy Study. She said the Policy and Research Section of the Bureau of Legislative Research (BLR) facilitates this study and provides some of the research that is presented to the Committees. She noted the information that must be reviewed in the Adequacy Study is spelled out in statute, which doesn't specifically require academic facilities to be addressed; but, the condition of school facilities was such a large part of the Lakeview School District lawsuit that the Education Committees have typically elected to include a review of the facilities funding program. Ms. Smith said the Adequacy Study reviewed the Partnership Program in October 2013, and, after sixteen (16) months of study, the Education Committees are now facing a November 1, 2014 deadline for developing recommendations and submitting a final report. She said that to help with the task, the BLR was asked to put together a list of issues that had surfaced during that time. She reviewed Adequacy Issues Related to Educational Facilities which describes three of the issues: 1) the \$65 million funding shortfall for the 2015-17 funding cycle, 2) disparities in the condition of school facilities from one district to another, and 3) ineligibility of openenrollment charter schools for Partnership Program funds. Ms. Smith said the Education Committees are meeting on Tuesday, October 14, to continue to discuss what to include in the final recommendations.

- ownership of buildings of schools that have been closed.

Senator Elliott stated that the Committee needs to make a generic recommendation to the full Education Committees on how facilities issues should be handled to fully fund the needs of adequacy. She said specific details will get worked out with legislation during the General Session.

facilities study to legislature for consideration.

The Honorable Scott Baltz, State Representative, District 61, was recognized, and seconded the motion.
