Act 1222 of 2011 requires the Department of Higher Education, the Department of Education, and the Bureau of Legislative Research to jointly conduct a study of the fairness of the distribution of Arkansas Academic Challenge Scholarships. The statute requires the agencies to provide progress reports and by June 1, 2012, a final report to the Arkansas Lottery Commission Legislative Oversight Committee.

The Arkansas Research Center has completed initial data analysis that links scholarship applicants and recipients to high school level data indicating financial need, gender, race, county of residence, and learning disability. The data also indicates the reasons unsuccessful applicants did not qualify for scholarships. The Department of Higher Education and the Bureau of Legislative Research will work together to review that product and complete the remaining steps to finalize the data results before March 20, 2012.

The Bureau of Legislative Research will schedule two public hearings. A list of barriers students experience when applying for scholarships will be developed through input at the public hearings. The Bureau will contact possible study group participants identified by the Department of Higher Education and the appropriate agency personnel. A career coach from the Department of Career Education will also be included.
