9 AN ACT TO AMEND THE MEMBERSHIP OF THE ARKANSAS  
10 LEGISLATIVE TASK FORCE ON SICKLE CELL DISEASE; TO  
11 EXTEND THE ARKANSAS LEGISLATIVE TASK FORCE ON SICKLE  
12 CELL DISEASE; AND FOR OTHER PURPOSES.

16 TO AMEND THE MEMBERSHIP OF THE ARKANSAS  
17 LEGISLATIVE TASK FORCE ON SICKLE CELL  
18 DISEASE; AND TO EXTEND THE ARKANSAS  
19 LEGISLATIVE TASK FORCE ON SICKLE CELL  
20 DISEASE.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Subsection (b) of Section 2 of Act 1191 of 2009 is amended  
26 to read as follows:

27 (b) The task force shall consist of the following members:

28 (1) Two (2) members of the House of Representatives appointed by  
29 the Speaker of the House of Representatives;

30 (2) Two (2) members of the Senate appointed by the President Pro  
31 Tempore of the Senate;

32 ~~(1)~~(3) One (1) member to represent Arkansas Children's Hospital;  
33 ~~(2)~~(4) One (1) member to represent the Sickle Cell Clinic of  
34 Arkansas Children's Hospital;

35 ~~(3)~~(5) One (1) member to represent the Newborn Screening Program  
36 of the Department of Health;



1           ~~(4)~~(6) One (1) member to represent the Office of Minority Health  
2 and Health Disparities of the Department of Health;

3           ~~(5)~~(7) One (1) member to represent the Arkansas Foundation for  
4 Medical Care;

5           ~~(6)~~(8) One (1) member to represent the Arkansas Minority Health  
6 Commission;

7           ~~(7)~~(9) One (1) member to represent Partners for Inclusive  
8 Communities of the University of Arkansas for Medical Sciences;

9           ~~(8)~~(10) One (1) member who is a patient suffering from Sickle  
10 Cell Disease; and

11           ~~(9)~~(11) One (1) member who is a parent of a patient suffering  
12 from Sickle Cell Disease.

14           SECTION 2. Section 2 of Act 1191 of 2009 is amended to add two  
15 additional sections to read as follows:

16           (h) The chair shall be one (1) of the legislative members of the task  
17 force and shall be selected by the legislative members of the task force.

18           (i) Legislative members of the task force may receive reimbursement  
19 for expenses and per diem at the same rate and from the same source as  
20 provided by law for members of the General Assembly attending meetings of  
21 interim committees.

23           SECTION 3. Section 4 of Act 1191 of 2009 is amended to read as  
24 follows:

25           The Arkansas Legislative Task Force on Sickle Cell Disease expires on  
26 October 1, ~~2013~~ 2015.
