How it began....

- Sub-committee of this task force recommended intensive intervention for young children
- Initial funding of \$1.5 million from a tobacco tax in 2009
- 1915(c) application was approved by CMS effective 10/1/2011
- First services: January of 2012





Initial Program

- 100 slots, phased in 10 children/month on a first come, first serve basis, as per instructions from the legislature
- DDS has expanded it twice
- Currently, the program has a maximum point-intime capacity of 180 children statewide





Program Design

- Early intensive in-home intervention program (services are delivered in the child's home and natural community settings)
- Eligible children are between 18 months and 8 years, must enter the program before their 5th birthday
- Maximum length of service is 3 years
- Utilizes a muti-disciplinary team
- NOT strictly an ABA program





Administrative Oversight

Partners team

- Responsible for:
 - Development and maintenance of a secure database
 - Recruiting, training & monitoring provider agencies
 - Managing application process, coordinating eligibility steps, and maintaining waiting lists
 - Overseeing all required processes in compliance with 1915 (c) application
 - Reporting to DDS





Waiver Services

Provided by Community-Based Disability Providers:

- Interventionist-master's level; responsible for evaluation and development/monitoring of individualized treatment plans
- Lead Therapist- bachelor's level; weekly oversight
- Line Therapist- delivers direct intervention

Provided by UA-Fayetteville, Dept of Curriculum & Instruction:

 Clinical Services Specialists-(BCBA-D)- independent treatment fidelity reviews





Unique Characteristics

- Natural environments only (child's home, church, Walmart, ballpark, etc.)
- Atypical hours- afternoons, evenings, weekends
- Parents are present and involved in treatment
- Program admin, service implementation and treatment review/assistance provided by different agencies- then DDS reviews it all
- Team members can bill simultaneously
- Child outcomes are tracked in addition to service utilization






Summary of Total Applicants

- Partners received 4,556 applications from the beginning of the program to September 26, 2025.
- Applicants represented all seventy-five counties in Arkansas, one county in Missouri and one in Tennessee.
- The counties with the greatest number of applications in the current fiscal year are Pulaski, Benton, Washington, Crittenden and Sebastian.






Total Applications Received by Program Year









Applicants By Gender January 1, 2012 to September 26, 2025




Applicants by Ethnicity from January 1, 2012 to September 26, 2025








Percentage of Applicants from January 1, 2012 to September 26, 2025 Compared to the U.S. Census Race Data







Children Receiving Services July 1, 2024 to June 30, 2025




Current Status of Participants July 1, 2024 to June 30, 2025








Children Receiving AAP Services July 1, 2024 to June 30, 2025 By Age at the Start of Services








Children With a Completed Application on the Autism Waiver Wait List Who Turned 5 Years Old Before a Slot Was Available in the Current Fiscal Year







Current Active Cases by Provider




All previously certified providers met the requirements for recertification. Their new certificates were sent on 9/1/2025 for a 10/1/2025 start date.






Required chart reviews and team contacts completed by Partners' Staff July 1, 2024 to June 30, 2025

Visit totals include new intake visits, renewal visits and problem/ transition visits.






Outcomes

- Historical ABLLS Comparison
 - 318 children who received the full autism waiver programming from 2012 until June 30, 2025 and have multiple ABLLS assessments.
 - The average initial ABLLS assessment score was 182 objectives with the final ABLLS assessment score of 749 objectives, a 412% increase.
 - Total number of objectives acquired per child ranged from 51 to 1347 with an average of 567 objectives.






Change in Workforce

Growth of Autism Waiver Workforce





- 6 years old
- Garland County
- Services by: First Step
- 18 months of service currently
- 514 objectives mastered, with 18 months of service remaining
- **8** team members

Evelyn is our beautiful, goofy, smart and tenderhearted six-year-old. I started noticing signs like sensory sensitivity and that Evelyn would get easily frustrated but could not ask for help. If I tried to help, she would get angry. Evelyn was diagnosed with Autism 2023. Later that year we started receiving services through the Arkansas Autism Partnership- Autism Waiver.

Evelyn has gone from playing alone all the time to seeking out friends and inviting them to play with her. She is an absolute chatterbox now and has reduced her frustration level by working with her autism waiver team. Her gain of social confidence has reduced our worries of her having a hard time interacting with others and just getting to be a kid. She has learned imaginary play and enjoys playing with her brother!

Evelyn loves her autism waiver team and looks forward to her sessions. The one-on-one interaction she has with the team is helping her grow mentally, emotionally and developmentally while improving her social interactions and skills though play. Evelyn loves it!

Current Need

- Applications as of September 26, 2025
 - 420 families actively working to complete application packets
 - 113 of these children will likely age out before a slot is available
 - 103 children with completed packets are on the autism waiver waiting list
 - 13 of these children will likely age out before a slot is available
