Co-Chair Mr. Rich Huddleston called the meeting to order.

The taskforce adopted the minutes of March 26, 2010 and April 13, 2010.

Mr. Huddleston recognized Elisabeth Wright Burak, Ark. Advocates for Children & Families who spoke on Health Care. Ms. Burak provided three handouts: How Health Reform Will Affect Arkansas Children and Families (AACF) (3/30/10), Crossing the Finish Line 2010: Moving Towards Covering all Kids, and Quick Wins: Who Will Be Helped Right Away By the New Health Care Reform Law.

Ms. Burak gave an overview of the health care reform law and what it means for children and low income families in the state of Arkansas. General information about health reform has been released, but the federal government is just now releasing details about the bill. Ms. Burak talked about who is and isn't currently covered by insurance in Arkansas and who will be covered under the new plan. Ms. Burak also discussed several benefits that will take effect in September of this year with parts of the bill being phased in each year thereafter. The bill will take full effect by 2014.

Mr. Huddleston overviewed the times and dates of the future town hall and taskforce meetings.

The next meeting is set for June 17, 2010, at 5:00 p.m. in Jonesboro, Arkansas.
