"AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES OF THE DEPARTMENT OF EDUCATION VOCATIONAL AND TECHNICAL EDUCATION DIVISION AND VOCATIONAL TECHNICAL SCHOOLS FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES - VOCATIONAL AND TECHNICAL EDUCATION
DIVISION. There is hereby established for the Department of Education Vocational and Technical Education Division for the 1987-89 biennium, the
following maximum number of regular employees whose salaries shall be governed
by the provisions of the Uniform Classification and Compensation Act, or its
successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars,
shall be exempt from the provisions of said Uniform Classification and
Compensation Act. All persons occupying positions authorized herein are
hereby governed by the provisions of the Regular Salaries Procedures and
Restrictions Act, or its successor.

SECTION 22. ALLOCATION RESTRICTION. Of the amounts allocated in Section 20 hereof, excluding the New Program Expense, Targeted Projects and Position Pool line items, such amounts are to be the maximum expended in the applicable fiscal year from the funds as appropriated in Section 19 hereof for the benefit of the appropriate area vocational technical school, so enumerated. Provided, however, that in the event that unforeseen circumstances occur in either fiscal year that would necessitate a transfer of the maximum allocation provided in Section 20 hereof from one or more programs to another

program or programs as enumerated in said Section 20, the Department shall make its request known, and the reasons thereof, to the Budget Division of the Department of Finance and Administration, in such form and detail as may be required by the Chief Fiscal Officer of the State, and when approved, such transfer approval shall be transmitted to the Research and Fiscal Services Division of the Bureau of Legislative Research, who shall make a report of the transfer and the reasons thereof to the Arkansas Legislative Council at least quarterly. Further provided, that nothing in this Section shall be construed in such manner as to allow a transfer between any items as set out in Section 19 hereof; nor that any transfer request of allocations be granted unless recommended by the governing body of the Vocational Schools and the Department of Finance and Administration. The maximum amount of the transfers to or from any of the aforementioned schools shall be limited to twenty percent (20%) of the amount so allocated to the affected schools in any one fiscal year.

SECTION 23. APPROPRIATIONS - VOCATIONAL TECHNICAL SCHOOLS - FEDERAL PROGRAMS. There is hereby appropriated, to the Department of Education - Vocational and Technical Education Division, to be payable from the Vocational Technical School Federal Fund, for personal services and operating expenses of the Department of Education - Vocational Technical Schools - Federal Programs for the biennial period ending June 30, 1989, the following:

SECTION 25. APPROPRIATIONS. There is hereby appropriated, to the Department of Education - Vocational and Technical Education Division, to be payable from the Vocational-Technical Education Contingency Fund, for miscellaneous vocational-technical educational programs of the Department of Education - Vocational and Technical Education Division for the biennial period ending June 30, 1989, the following:

SECTION 27. The funds appropriated in Section 26 of this Act shall only be used in the event that federal funds made available through the Job Training Partnership Act are not made available for the program set out in Section 26 of this Act.

SECTION 28. TRANSFER OF FUNDS. Transfer of funds between various established federal accounts for educational programs financed by either or both State and Federal funds for the purpose of clearing audit exceptions, adjustments in matching requirements, or to provide initial program financing or existing program financing pending availability of funds from the Federal Government, or for the purpose of prorating direct or indirect costs are hereby authorized.

SECTION 29. TRANSFER PROVISION - VOCATIONAL, TECHNICAL AND ADULT EDUCATION - INDUSTRY TRAINING PROGRAM. During either fiscal year of the 1987-89 biennium, any savings accomplished in line item (02) of Section 6 of this Act, Extra Help, may be transferred to line item (04) of Section 6 of this Act, Maintenance and General Operation.

SECTION 30. The Director of the Vocational and Technical Education Division is hereby authorized to enter into contracts with private organizations, licensed by the State Board of Education, in order to provide vocational-technical training to citizens of the State of Arkansas.

SECTION 31. Teachers of Home Economics shall be reimbursed for travel in the same manner as provided for teachers of Agriculture.

SECTION 32. LINE ITEM ESTABLISHMENT. There is hereby authorized for the Department of Education, Area Vocational Technical Schools, a line item entitled Part-Time Instructors, which may be created after seeking the advice of the Arkansas Legislative Council. This line item shall be used solely for the payment of instructors teaching night or extension classes on a part-time basis.

SECTION 33. TRANSFER PROVISION. During either fiscal year of the 1987-89 biennium, the Director, Vocational and Technical Education Division, after receiving authorization from the Chief Fiscal Officer of the State who has requested advice of the Arkansas Legislative Council, may transfer appropriation from Extra Help and Personal Services Matching as provided in Items (02) and (03), respectively of Section 19 of this Act, Items (02) and (03), respectively of Section 22 of this Act, and Items (01) and (02), respectively of Section 23 of this Act, to the Line Item Part-Time Instructors created by Section 29 of this Act. Nothing in this Act is construed as an authority to transfer a like amount of current year general revenue to finance the intent of this provision - financing the provisions of this Act shall be provided within the appropriations and financing authority as authorized by the General Assembly.

SECTION 34. TRANSFER PROVISION. The Director, Vocational and Technical Education Division, shall have full authority after notification of the Chief Fiscal Officer of the State to transfer the appropriations from the New Program Expenses Line Item provided for in Section 19 of this Act to any other line item appropriated herein. It is the intent of the General Assembly and the Governor that the appropriation made herein for New Programs be utilized to expand the offering of courses by the Vocational Technical Schools in the State to include high technology and to allow for full participation in the Federal Job Training Project program or to serve increased numbers of students.

SECTION 35. REGULAR SALARIES - PROVISIONAL. It is hereby established that if during either fiscal year of the 1987-89 biennium, private gifts, grants, or donations become available and that such funds make it possible for the Vocational and Technical Education Division to engage in educational pro-

jects that would be of benefit to the State of Arkansas, and that such projects make it necessary to employ additional personnel, which were not contemplated at the time of the passage of this Act, the State Board of Vocational Education, upon seeking the advice of the Arkansas Legislative Council, shall certify to the Chief Fiscal Officer the need to establish one or more new additional positions, at salary rates not to exceed the maximum salaries established for comparable positions in the Regular Salaries Section of this Act, but in no event shall the Chief Fiscal Officer authorize the establishment of more than twenty-five (25) new or additional employees. The Chief Fiscal Officer shall certify to the State Auditor and the State Treasurer such approval of additional positions.

SECTION 36. The Department of Education - Vocational-Technical Schools shall be limited to a maximum of ninety-six (96) filled positions in utilizing the title of Vocational Instructor IV/Grade 19, two hundred eighteen (218) filled positions in utilizing the title of Vocational Instructor III/Grade 18, five hundred twenty-nine (529) filled positions in utilizing the title of Vocational Instructor II/Grade 17, and twelve (12) filled positions in utilizing the title of Vocational Instructor I/Grade 15. At no time during the 1987-89 biennium shall the combined use of all titles referenced above (Vocational Instructor IV, III, II and I) exceed five hundred forty-six (546) total filled positions.

SECTION 37. The positions of Vo-Tech Technician II and of Vo-Tech Technician I, as authorized in Items (1) and (2) of Section 2 of this Act may be utilized only in the event that high technology programs are approved by the State Board of Vocational Education which require instructors who cannot be employed at the rates of pay approved for other vocational technical instructors. Such positions shall be restricted to use in high technology or critical skills area programs as defined by rules and regulations promulgated by the State Board.

SECTION 38. TRANSFER OF APPROPRIATION. If during either fiscal year of the 1987-89 biennium, private funds and donations, gifts, or grants become available for new, expanded, or continuing vocational-technical educational programs, the State Board of Vocational Education is hereby authorized to

request the Chief Fiscal Officer of the State to transfer to any line item appropriation from the Vocational-Technical Schools Fund Account provided in Section 19 herein, additional appropriation provided in Section 24 herein, as needed, not to exceed the amount of funds deposited into the Vocational-Technical Education Contingency Fund and transferred to the Vocational-Technical Schools Fund Account for purposes as provided by law.

SECTION 39. PERSONNEL TRANSFER PROVISION. Any positions with supporting appropriation as authorized in Section 1 of this Act may be transferred to a vocational-technical school as needed. Any positions with supporting appropriation as authorized in Section 2 of this Act may be transferred to the Vocational and Technical Education Division as needed. Provided, however, the maximum amount of positions or appropriations transferred shall be limited to ten percent (10%) of the total number of authorized positions and supporting appropriation for any one vocational-technical school. The transfer of any position and supporting appropriation must be requested by the Director, Vocational and Technical Education Division, Department of Education, and any such transfer will require prior approval of the Governor and the Chief Fiscal Officer of the State. In no event shall this language be used to increase the Central Office Administration, unless the Governor determines that sufficient savings are to be effected in overall administration of the vocational programs of the State of Arkansas to justify said transfer.

SECTION 40. Funds made available to support the appropriation in Item (05) of Section 6 herein shall be used to acquire capital equipment necessary to enhance the quick-start capabilities of the Arkansas Industry Training Programs. When not in use in an AITP managed training course, the equipment shall be stored in the Equipment Maintenance and Distribution Center operated by the Vocational and Technical Education Division or at one of the State vocational technical schools on a loan agreement which contains a twenty-four hour recall provision.

SECTION 41. The Director of the Vocational and Technical Education
Division shall be authorized, after notifying the Chief Fiscal Officer of the
State, to transfer funds and appropriation from the Extra Help and Personal
Services Matching line items provided for in Section 6 to any vocational tech-

nical school line item provided in this Act or to any public community college, two-year college, or university. Provided, however, such transfer shall be limited to those funds and appropriation provided for in Section 6 which have been designated by the Vocational and Technical Education Division for apprenticeship and industry training.

SECTION 42. TRANSFER PROVISION. Any position, appropriation and funds as authorized in this Act for the Associate Degree Nursing Program may be transferred to a public community college, two year college or university as needed to accomplish the purpose of the Associate Degree Nursing Program.

The transfer of the positions, appropriations and funds must be requested by the Director, Vocational and Technical Education Division, Department of Education and such transfers will require prior approval of the Chief Fiscal Officer of the State.

SECTION 43. TRANSFER PROVISION - VOCATIONAL TECHNICAL SCHOOLS. The Director of the Vocational and Technical Education Division shall be authorized, after approval by the Chief Fiscal Officer of the State who has sought the advice of the Legislative Council, to transfer appropriation from Line Item (01), Regular Salaries, to Line Item (02), Extra Help of Section 19 of this Act, in an amount or amounts which shall not exceed an increase of twenty percent (20%) of the amount appropriated for Extra Help. Any such transferred funds and appropriations must be from savings and for the purpose of improving effectiveness and efficient operation of said vocational technical schools.

SECTION 44. TRANSFER PROVISION. The funds and appropriations as authorized in this Act for new technology-based associate degree programs may be transferred to the Arkansas State Technical Institute - Arkansas State University - Beebe as needed to accomplish the purposes of programs approved by the State Board of Vocational Education. The transfer of the funds and appropriation in this Section must be requested by the Director, Vocational and Technical Education Division, Department of Education and receive prior approval of the Chief Fiscal Officer of the State, after seeking the advice of the Arkansas Legislative Council.

SECTION 45. TRANSFER PROVISION. The Division Director for Vocational-Technical Schools shall have full authority after notification of the Chief Fiscal Officer of the State to transfer the appropriation from the Targeted Projects line item provided for in Section 20 of this Act to any other line item appropriated herein.

SECTION 47. The funds appropriated in Section 46 of this Act shall only be used in the event that federal funds made available through the Job Training Partnership Act are not made available for the program set out in Section 46 of this Act.

SECTION 48. TRANSFER PROVISION - INDUSTRY TRAINING. During either fiscal year of the 1987-89 biennium, any savings accomplished in Item (05) of Section 6 of this Act, Industry Training Program Equipment, may be transferred to Items (02) or (04) of Section 6 of this Act, Extra Help and Maintenance & General Operations, respectively, for the exclusive purpose of Industry Training related to new plants or plant expansions and after prior approval of the Governor and notice to the Chief Fiscal Officer of the State.

SECTION 49. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be

strictly complied with in disbursement of said funds.

SECTION 50. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 51. CONTRACT RESTRICTIONS. The agency, board, commission, department or institution to whom funds are appropriated by this Act shall not enter into any contract for any professional or consultant services which shall extend for more than twenty (20) actual working days or the total compensation exceeds five thousand dollars (\$5,000) during any one fiscal year without first seeking the advice of the Arkansas Legislative Council. Provided further, that all contracts for professional or consultant services shall be submitted monthly to the Chief Fiscal Officer of the State for reporting to the Legislative Council.

SECTION 52. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1987 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1987 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1987.
