HOUSE BILL 1825

"AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF HUMAN SERVICES FOR CONSTRUCTION AND MODIFICATIONS TO FACILITIES OPERATED BY ITS VARIOUS DIVISIONS AND OFFICES; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. There is hereby appropriated to the Department of Human Services - Mental Health Services Division, to be payable from the General Improvement Fund or its successor fund or fund accounts for the Department of Human Services - Mental Health Services Division, the following:

(A) Effective July 1, 1987, the balance of the appropriation provided in Item (A) of Section 1 of Act 594 of 1985 for equipment, major maintenance, renovations and repairs, in a sum not to exceed.....\$122,992.

(B) Effective June 30, 1987, the balance of the appropriation provided in Item (A) of Section 1 of Act 378 of 1985 for construction, replacement, and equipping of the Benton Nursing Home, in a sum not to exceed.....\$33,545.

SECTION 2. There is hereby appropriated to the Department of Human Services - Children and Family Services Division, to be payable from the General Improvement Fund or its successor fund or fund accounts for the Department of Human Services - Children and Family Services Division, the following:

(A) Effective July 1, 1987, the balance of the appropriation provided in Item (A) of Section 2 of Act 594 of 1985 for construction of cottages at the Pine Bluff Youth Service Center, in a sum not to exceed.....\$83,259.

SECTION 3. There is hereby appropriated to the Department of Human Services - Administration, to be payable from the General Improvement Fund or

its successor fund or fund accounts for the Department of Human Services - Administration, the following:

(A) Effective July 1, 1987, the balance of the appropriation provided in Section 1 of Act 588 of 1985 for grants to aid in constructing, renovating, equipping and maintaining residential treatment facilities for emotionally/behaviorially disturbed youth, in a sum not to exceed....\$100,000.

SECTION 4. There is hereby appropriated to the Department of Human Services - Administration, to be payable from the Department of Human Services Renovation Fund for the Department of Human Services - Administration, the following:

(A) Effective July 1, 1987, the balance of the appropriation provided in Section 2 of Act 719 of 1985 for construction, renovation, maintenance, repairs to and equipment for the various buildings operated by the Department of Human Services and for paying disallowances by the federal government, in a sum not to exceed\$4,850,000.

SECTION 5. There is hereby appropriated to the Department of Human Services - Rehabilitation Services Division, to be payable from the General Improvement Fund or its successor fund or fund accounts for the Department of Human Services - Rehabilitation Services Division, the following:

(A) Effective July 1, 1987, the balance of the appropriation provided in Item (A) of Section 3 of Act 594 of 1985 for replacement of floor covering in hospital and dormitory areas of the Hot Springs Rehabilitation Center, in a sum not to exceed.....\$21,300.

(B) Effective July 1, 1987, the balance of the appropriation provided in Item (B) of Section 3 of Act 594 of 1985 for construction of a stairwell to provide a secondary exit at the Hot Springs Rehabilitation Center, in a sum not to exceed\$35,000.

SECTION 6. There is hereby appropriated to the Department of Human Services - Developmental Disabilities Services Division, to be payable from the General Improvement Fund or its successor fund or fund accounts for the Department of Human Services - Developmental Disabilities Services Division, the following:

(A) Effective April 17, 1987, the balance of the appropriation provided

in Item (B) of Section 2 of Act 378 of 1985 for constructing, equipping and associated costs for the Southeast Arkansas Human Development Center, in a sum not to exceed\$31,129.

(B) Effective March 29, 1987, the balance of the appropriation provided in Item (D) of Section 2 of Act 378 of 1985 for constructing and equipping a men-

tal retardation facility at Jonesboro, in a sum not to exceed\$5,179.

(C) Effective March 19, 1987, the balance of the appropriation provided in Item (E) of Section 2 of Act 378 of 1985 for renovation and equipping of classrooms at the Conway Unit, in a sum not to exceed\$3,704.

(D) Effective June 30, 1987, the balance of the appropriation provided in Item (H) of Section 2 of Act 378 of 1985 for maintenance, renovation and repair of roofs on various buildings at the Human Development Centers, in a sum not to exceed\$20,375.

SECTION 7. There is hereby appropriated to the Department of Human Services - Developmental Disabilities Services Division, to be payable from the Developmental Disabilities Services - Intermediate Care Facilities Renovation Fund for the Department of Human Services - Developmental Disabilities Services Division, the following:

(A) Effective June 30, 1987, the balance of the appropriation provided in Item (A) of Section 3 of Act 378 of 1985 for additions, maintenance, renovation, and repair of cottage patio areas at the Arkadelphia Human Development Center, in a sum not to exceed.....\$110,100.

SECTION 8. DEVELOPMENTAL DISABILITIES - CASH. There is hereby appropriated to the Department of Human Services - Developmental Disabilities Services Division, to be payable from cash funds of the Department of Human Services - Developmental Disabilities Services Division for the Department of Human Services - Developmental Disabilities Services Division, the following:

(A) Effective June 30, 1987, the balance of the appropriation provided in Item (B) of Section 4 of Act 378 of 1985 for construction of a building to house the therapeutic pool and therapeutic exercise facility in Booneville, in a sum not to exceed\$750,000.

(B) Effective June 30, 1987, the balance of the appropriation provided in Item (C) of Section 4 of Act 378 of 1985 for constructing and equipping a thera-

peutic pool complex at the Arkadelphia Human Development Center, in a sum not to exceed.....\$30,000.

(C) Effective July 1, 1987, for maintenance and general operation in a sum not to exceed.....\$37,000.

(D) Effective July 1, 1987, for construction and capital outlay expenditures, in a sum not to exceed.....\$140,953.

SECTION 9. DISBURSEMENT CONTROLS. (A) No contract may be awarded or obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that the Institutions and Agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income, and/or funds available to it, for the purpose of supplementing the said State Treasury funds for financing the entire costs of said project or projects. Provided further, that the appropriations and funds otherwise provided by the General Assembly for maintenance and general operation of the said Institutions and Agencies shall not be used for any of the purposes set out in this Act.

(B) The General Accounting Procedures Law, the State Purchasing Law, the Revenue Stabilization Law, and other applicable fiscal laws of the State, or their successors, shall be strictly complied with, with respect to use of any funds provided by this Act.

SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that previous General Assemblies have provided appropriations for the projects enumerated in this Act; that certain appropriations will expire before the adjournment of the Regular Session; and that if such appropriations expire, the programs authorized by such appropriations would cease, thereby depriving the citizens of the State of the benefits to be derived from such projects. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after its passage and approval.
