SENATE BILL 263

"AN ACT TO PRESCRIBE THE SALARIES OF DEPUTIES AND OTHER
EMPLOYEES OF THE SEPARATE CHANCERY COURT CLERKS OF PULASKI
COUNTY; AND FOR OTHER PURPOSES."

WHEREAS, there are several legislative enactments authorizing the various employees working in the Pulaski County Chancery Clerk's Office; and

WHEREAS, most of the employees are authorized by Act 501 of 1985; and

WHEREAS, the duties of the employees of the Pulaski County Standing Master were transferred to the Chancery Clerk's responsibility by Act 989 of 1985 and Act 12 of 1986 Special Session and have now relocated to the Chancery Clerk's Office; and

WHEREAS, these separate legislative enactments should be consolidated under one act,

NOW THEREFORE,

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. In addition to the salary of the Chancery Clerk, employees of the Chancery Clerk of Pulaski County shall be paid as follows unless a higher salary is provided by county ordinance:

SECTION 2. The above salaries are retroactive and shall go into effect January 1, 1987.

SECTION 3. Sections 20, 21, and 22 of Act 336 of 1985 are hereby repealed.

SECTION 4. All laws and parts of laws in conflict with this Act are hereby repealed.

SECTION 5. EMERGENCY. It is hereby found and determined by the General Assembly that the duties of the Chancery Clerk of Pulaski County and his employees require sufficient compensation for the proper administration of justice and the immediate passage of this Act is necessary to provide the same. Therefore, an emergency is hereby declared to exist and this Act being necessary for the preservation of the public peace, health and safety shall be in full force and effect from and after its passage and approval.
