SECTION 44. TRANSFER OF STATE FUNDS - HISTORIC PRESERVATION PROGRAM. Subject to such rules and regulations as may be implemented by the Chief Fiscal Officer of the State and after seeking the advice of the Arkansas Legislative Council, the Historic Preservation Officer is hereby authorized to transfer funds and appropriations for Regular Salaries; Personal Services Matching (Social Security, Retirement, Workmen's Compensation and Unemployment Insurance) Maintenance and Operations; Grants; Conference Fees and Travel; Professional Services; and Extra Help; under the various sections in this Act which appropriate State Funds, whenever it appears by projecting the expenditures of any of these appropriations that there will be a need of funds or appropriations in one item and that there is an excess of funds or appropriations in another item. The transfer of appropriations and funds shall be effected only upon approval of the Chief Fiscal Officer of the State, who will then authorize the State Treasurer and State Auditor to adjust the effected accounts on their books of record respectively.

SECTION 45. In addition to any other rights, powers, functions and duties granted by law to the Department of Arkansas Heritage, the Department is hereby authorized to promote and cooperate in the establishment under the Arkansas non-profit corporation laws of a Heritage Foundation, to share resources and facilities with the foundation and to accept support and assistance in the form of money, property or otherwise from the foundation to be used to preserve and promote the heritage of the State.

SECTION 46. If a Heritage Foundation is established and the Department shares resources or facilities with the Foundation or accepts support and assistance from the Foundation, the Foundation shall annually file a report with the Governor, the Legislative Council, and the Legislative Joint Auditing committee showing the amount and source of all gifts, grants, and donations of money or property received by the Foundation and all expenditures or other dispositions of money or property by the Foundation during the preceding year.

SECTION 47. The Director of the Department of Arkansas Heritage shall, on or before July 1 of each fiscal year, submit a plan to the Arkansas Legislative Council reflecting the proposed uses of private funds for the ensuing fiscal year for its review and comment. No person over which the Department of Arkansas Heritage has day to day managerial control, shall receive compensation or renumeration from funds not in the State Treasury.

SECTION 48. STATE SEAL. No monies may be expended by the Department of Arkansas Heritage for the purchase of any state printing contract item, until the Great Seal of the State of Arkansas is placed on the letterhead of all agencies and commissions within the Department of Arkansas Heritage.

SECTION 49. The following positions; (A) 1 (one) N370 Architectural Historian Grade 20; (B) 1 (one) R266 Management Project Analyst II Grade 19 authorized in Section 9 of this Act shall be financed by any increase in the Real Estate Transfer Tax enacted by the 76th General Assembly and made available to the Arkansas Natural and Cultural Resources Council for the "Main Street" Program.

SECTION 50. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds. SECTION 51. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 52. CONTRACT RESTRICTIONS. The agency, board, commission, department or institution to whom funds are appropriated by this Act shall not enter into any contract for any professional or consultant services which shall extend for more than twenty (20) actual working days or the total compensation exceeds five thousand dollars (\$5,000) during any one fiscal year without first seeking the advice of the Arkansas Legislative Council. Provided further, that all contracts for professional or consultant services shall be submitted monthly to the Chief Fiscal Officer of the State for reporting to the Legislative Council.

SECTION 53. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1987 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1987 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1987.
