"AN ACT TO MAKE AN APPROPRIATION TO PAY THE SALARIES OF THE GOVERNOR'S LEGISLATIVE LIAISONS AND LEGISLATIVE CLERK DURING THE FIRST EXTRAORDINARY SESSION OF THE SEVENTY-SIXTH SESSION OF THE ARKANSAS GENERAL ASSEMBLY; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. EXTRA HELP. There is hereby authorized, for the Office of the Governor - Legislative Liaison Staff for the fiscal year ending June 30, 1987, the following maximum number of part-time or temporary employees, to be known as "Extra Help," payable from funds appropriated herein for such purposes and on a weekly basis:

SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the Governor's Office, to be payable from the Constitutional and Fiscal Agencies Fund, for personal services and operating expenses for the Office of the Governor - Legislative Liaison Staff for the biennial period ending June 30, 1987, the following:

SECTION 3. PAYMENT OF SALARIES. Salaries as authorized in Section 1 of this Act shall be in effect from and after June 2, 1987.

SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriation; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by Law, shall be strictly complied with in disbursement of said funds.

SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, meeting in First Extraordinary Session, that monies were not provided by the Seventy-Fifth General Assembly to pay the salary and expenses of Legislative Liaisons and Clerk needed by the Governor to effectively carry out the duties of this office, that the services so provided are essential to provide effective coordination between the Governor's Office and the General Assembly; that the provisions of this Act will provide the necessary monies for such salaries and expenses; and that delay in the effective date of this Act could work irreparable harm upon the proper administration and provision for essential governmental services. Therefore, an emergency is hereby declared to exist and this Act, being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after its passage and approval.
