HOUSE MEMORIAL RESOLUTION

IN RESPECTFUL MEMORY OF MR. THOMAS D. WYNNE, JR., OF FORDYCE AND IN RECOGNITION OF HIS MANY CONTRIBUTIONS TO HIS COUNTRY AND STATE AND TO HIS LOCAL COMMUNITY.

WHEREAS, Mr. Thomas D. Wynne, Jr., of Fordyce, Arkansas, died on Tuesday, September 29, 1987; and

WHEREAS, Mr. Wynne was a graduate of the University of Arkansas School of Law at Fayetteville where he lettered in both Razorback football and track; and

WHEREAS, Mr. Wynne was the senior partner in the law firm of Wynne, Wynne and Wynne in Fordyce where his partners were two of his sons, Thomas D. Wynne III, and State Representative Robin Wynne; and

WHEREAS, Mr. Wynne served as mayor of Fordyce for twelve years, Fordyce municipal judge for ten years and deputy prosecuting attorney for ten years; and

WHEREAS, Mr. Wynne was a retired lieutenant colonel in the U. S. Air Force where he flew thirty-two missions during World War II and he was the recipient of the U. S. Air Force Silver Star, two Flying Crosses, the Purple Heart, and various other medals and awards; and

WHEREAS, Mr. Wynne was active in community and church affairs, having served as president of the Fordyce Chamber of Commerce, vice president of the Arkansas Municipal League, member of the Fordyce Rotary Club and chairman of the board of trustees of First United Methodist Church of Fordyce; and

WHEREAS, Mr. Wynne was a highly respected businessman and civic leader, and his death is a great loss to his country, the state of Arkansas, to his local community and to the members of his family,

NOW THEREFORE,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SECOND EXTRAORDINARY SESSION OF THE SEVENTY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
