HOUSE BILL 1012

"AN ACT TO AMEND VARIOUS SECTIONS OF ACT 882 OF 1987 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Section 2 of Act 882 of 1987 is hereby amended to read as follows:

"SECTION 2. EXTRA HELP - HORSE RACING. There is hereby authorized, for the Department of Finance and Administration - Division of Racing - Horse Racing, for the 1987-89 biennium, the following maximum number of part-time or temporary employees, to be know as 'Extra Help', payable from funds appropriated herein for such purposes and on a daily basis:

SECTION 4. EMERGENCY CLAUSE.
