

HOUSE RESOLUTION

COMMENDING MR. FRANK BROYLES, UNIVERSITY OF ARKANSAS ATHLETIC DIRECTOR, MR. KEN HATFIELD, ARKANSAS RAZORBACK FOOTBALL COACH, AND MR. NOLAN RICHARDSON, ARKANSAS RAZORBACK BASKETBALL COACH FOR THEIR ATHLETIC ACCOMPLISHMENTS AND FOR THEIR PROMOTION OF HIGH ACADEMIC AND MORAL STANDARDS AND CHRISTIAN PRINCIPLES TO GUIDE THE UNIVERSITY OF ARKANSAS RAZORBACK ATHLETES.
