SENATE BILL 1

"AN ACT TO MAKE A SUPPLEMENTAL APPROPRIATION FOR THE ARKANSAS
SENATE FOR THE THIRD EXTRAORDINARY SESSION OF THE SEVENTY
SIXTH GENERAL ASSEMBLY; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. There is hereby appropriated, to be payable from the Constitutional Officers Fund, to the Arkansas Senate for additional personal services, operating expenses, per diem and mileage which shall be supplemental and in addition to those funds provided under Act 2 of 1987, the sum of\$75,000.

SECTION 2. Items (6) & (7) of Section 2 of Act 2 of 1987 are hereby amended to read as follows:

"(6) Secretary of the Senate \$60,000
(7) Senate Fiscal Officer \$55,450"

SECTION 3. Items 1 through 4 of Section 1 of Act 15 of 1987 are hereby amended to read as follows:

"(1) Senate Chief of Staff	45,000	45,000
(2) Senate Assistant Chief of Staff	40,000	40,000
(3) Senate Information Director	35,000	35,000
(4) Executive Secretary	23,000	23,000"

SECTION 4. There is hereby appropriated, to be payable from the State Central Services Fund to the Arkansas Senate for additional personal services of the Arkansas Senate for the remainder of the biennial period ending June 30, 1989, which such appropriation shall be supplemental and in addition to that provided by Section 2 of Act 15 of 1987, and for the same purpose the

following:

SECTION 5. Section 2 of Act 38 of the First Extraordinary Session of the Seventy-Sixth General Assembly (approved June 19, 1987), is hereby amended to read as follows:

"SECTION 2. The Senate Fiscal Officer shall report directly to and be responsible directly to the Senate Efficiency Committee."

SECTION 6. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly meeting in Third Extraordinary Session, that the appropriation for the Arkansas Senate as provided by Act 2 of 1987 did not anticipate the convening by the Governor of extraordinary sessions and that additional appropriation must be provided to defray such additional costs as may be incurred. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.
