BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the Department of Education - General Education Division for the 1989-91 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act, or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

SECTION 41. No school based health clinic may be established in a public school until requested by resolution signed by the school board of directors.

SECTION 42. SECTION 44. TRANSFER OF FUNDS. SECTION 45. FEDERAL TURNBACK FUNDS. Any Federal Mineral Leasing Funds, Federal Forest Reserve Funds, Federal Flood Control Funds, or any similar turnback funds in the State Treasury for which the eligible county and/or school district cannot be identified may be transferred to the Public School Fund and used for any lawful school purpose.

SECTION 46. Teachers of Home Economics shall be reimbursed for travel in the same manner as provided for teachers of Agriculture.

SECTION 47. CARRY FORWARD. At the close of the fiscal year ending June 30, 1990, any unexpended balance of appropriation and monies provided from the Department of Education Fund Account for professional fees, as provided in Sections 14 and 15 of this Act, shall be transferred forward and made available for the same purpose for the fiscal year ending June 30, 1991.

SECTION 48. Should the utilization of all funds appropriated for the implementation of Computer-Based Educational programs necessitate the employment of additional personnel which were not contemplated at the time of the passage of this Act, the State Department of Education shall certify to the Chief Fiscal Officer of the State the need to establish one or more new additional positions. The Chief Fiscal Officer of the State may establish such additional positions, at salary rates not to exceed the maximum salary rates established for comparable positions in the Department of Computer

Services, in addition to the positions authorized in the Regular Salaries Section of the Department of Education Biennial Operations Appropriation Act, but in no event shall the total number of such positions during any fiscal year exceed nine (9) additional positions.

SECTION 49. CARRY FORWARD. At the close of the fiscal year ending June 30, 1990, any unexpended balance of appropriation and monies provided for the procurement, development and validation of examinations in basic academic skills shall be transferred forward and made available for the same purpose for the fiscal year ending June 30, 1991.

SECTION 50. For the biennial period ending June 30, 1991, an amount not to exceed \(\$ 150,000\) may be transferred from the Public School Fund to the Department of Education Fund Account for the purpose of funding the program for procurement, development and validation of examinations in basic academic skills.

SECTION 51. Funds not to exceed \(\$ 75,000\) in any fiscal year of the 1989-91 biennium may be transferred from the Public School Fund to the Department of Education Fund Account for the purpose of funding the program of Teacher Examination Validation.

SECTION 52. The Appropriation provided by Section 27 of this Act for the Early Childhood Program shall be utilized only in the area of kindergarten to third grade, and shall not be used for any time spent, resources or effort on programs for pre-school aged children three to four years old.

SECTION 53. Any driving simulators in the possession of the Department of Education on the effective date of this Act shall be transferred to the various education service area cooperatives, there to be used by local school districts. Provided, however, that no State funds shall be expended by the various cooperatives for the maintenance and operation of such driving simulators.

SECTION 54. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency
and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 55. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 56. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 57. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Seventh General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1989 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1989 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1989.```
