For An Act To Be Entitled

"AN ACT TO ABOLISH THE STATE LABOR BOARD, THE COAL MINE EXAMINING BOARD, AND THE ARKANSAS EMPLOYMENT AGENCY ADVISORY COUNCIL AND TRANSFER THEIR AUTHORITY TO THE DIRECTOR OF THE DEPARTMENT OF LABOR; TO ABOLISH THE JUDICIAL ETHICS COMMITTEE, THE SCHOOL HEALTH SERVICES ADVISORY COUNCIL, THE MERIT SYSTEM BOARD, THE MEDICAL SERVICES ADVISORY COMMISSION, THE ADVISORY BOARD ON THE CONTROL OF LITTER AND JUNK, THE TECHNICAL EDUCATION REVIEW COMMISSION, AND THE COMMUNITY SERVICES ADVISORY BOARD; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. The State Labor Board created by Arkansas Code 11-4-207 is hereby abolished and its powers, duties and functions transferred to the Director of the Department of Labor.

SECTION 2. The Coal Mine Examining Board created by Arkansas Code 11-7-401 is hereby abolished and its powers, duties and functions transferred to the Director of the Department of Labor.

SECTION 3. The Arkansas Employment Agency Advisory Council created by Arkansas Code 11-11-205 is hereby abolished and its powers, duties and functions transferred to the Director of the Department of Labor.

SECTION 4. The Judicial Ethics Committee created by Arkansas Code 16-10-302 is hereby abolished and Arkansas Code sections 16-10-301 through 307 are hereby repealed.

SECTION 5. The Governor's Council for School Health Services created by Arkansas Code 6-1-201 is hereby abolished and Arkansas Code sections 6-1-201 through 6-1-205 are hereby repealed.

SECTION 6. The Merit System Board created by Arkansas Code 21-3-402 is hereby abolished and Arkansas Code sections 21-3-401 through 404 are hereby repealed.

SECTION 7. The State Medical Services Advisory Commission created by Arkansas Code 20-9-401 is hereby abolish, and Arkansas Code sections 20-9-401 through 404 are hereby repealed.

SECTION 8. The Advisory Board on the Control of Litter and Junk created by Arkansas Code 8-6-417 is hereby abolished.

SECTION 9. The Technical Education Review Commission created by Arkansas Code 6-50-202 is hereby abolished, and Arkansas Code sections 6-50-201 through 207 are hereby repealed.

SECTION 10. The Community Services Advisory Board created by Arkansas Code 20-80-308 is hereby abolished.

SECTION 11. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 12. All laws and parts of laws in conflict with this Act are hereby repealed.
