HOUSE BILL 1889

"AN ACT TO AMEND THE ARKANSAS CODE OF 1987 TITLE 19, CHAPTER 4, SECTION 906 (a) TO PROVIDE FOR THE MAXIMUM NUMBER OF AUTHORIZED PASSENGER MOTOR VEHICLES TO BE OPERATED IN ANY YEAR BY THE VARIOUS STATE AGENCIES, AUTHORITIES, BOARDS, COMMISSIONS, DEPARTMENTS, AND INSTITUTIONS OF HIGHER EDUCATION; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code of 1987 19-4-906 (a) is hereby amended to read as follows:

"(a) None of the funds appropriated for the various state agencies, authorities, boards, commissions, departments, and institutions of higher education listed below shall be used to purchase, lease for over thirty (30) days, operate, repair, or provide services for more than the maximum number of passenger motor vehicles as set out in this section, except in an emergency as proclaimed by the Governor. Passenger motor vehicles are defined as those licensed for highway use including, but not limited to, automobiles, trucks, and vans. Mileage reimbursement for employees' utilization of their personal automobiles shall not be deemed to be included in this restriction.

SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized his Act shall be limited to the appropriation for such agency and funds made lable by law for the support of such appropriations; and the restrictions of State Purchasing Law, the General Accounting and Budgetary Procedures Law, Revenue Stabilization Law, the Regular Salary Procedures and Restrictions or their successors, and other fiscal control laws of this State, where icable, and regulations promulgated by the Department of Finance and nistration, as authorized by law, shall be strictly complied with in ursement of said funds.

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly any funds disbursed under the authority of the appropriations contained in Act shall be in compliance with the stated reasons for which this Act was ted, as evidenced by the Agency Requests, Executive Recommendations and slative Recommendations contained in the budget manuals prepared by the rtment of Finance and Administration, letters, or summarized oral testimony he official minutes of the Arkansas Legislative Council or Joint Budget

ittee which relate to its passage and adoption.

SECTION 4. All provisions of this Act of a general and permanent nature amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Commission shall incorporate the same in the Code.

SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the nty-Seventh General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that effectiveness of this Act on July 1, 1989 is essential to the operation of agency for which the appropriations in this Act are provided, and that in event of an extension of the Regular Session, the delay in the effective of this Act beyond July 1, 1989 could work irreparable harm upon the proper nistration and provision of essential governmental programs. Therefore, an agency is hereby declared to exist and this Act being necessary for the diate preservation of the public peace, health and safety shall be in full e and effect from and after July 1, 1989.
