HOUSE CONCURRENT RESOLUTION

IN RESPECTFUL MEMORY OF MR. JULIAN C. HOGAN AND IN RECOGNITION
OF HIS MANY YEARS OF DEDICATED PUBLIC SERVICE TO THE STATE OF
ARKANSAS.

WHEREAS, Mr. Julian C. Hogan departed this life on January 16, 1989; and

WHEREAS, Mr. Hogan was born in Batesville, Arkansas, on March 13, 1902,
and spent his entire life in the state of Arkansas; and

WHEREAS, Mr. Hogan started work with the State Auditorial Department in
the spring of 1922 as a Budget Clerk, was advanced to Budget Director in 1933,
and served as Director of the State Administration Department from August 1967
to July 1968; and

WHEREAS, Mr. Hogan retired from state service on August 1, 1969, after
having served the State of Arkansas more than forty years, during which Mr.
Hogan earned and received the highest respect and admiration of his fellow
workers and of the many Governors under whom he served; and

WHEREAS, while Mr. Hogan is probably best known and remembered for his
honesty and integrity and his total commitment and dedication to his work, his
greatest contribution to the State was probably a proposal for a new method of
allocating and distributing state funds to finance state services, which was
enacted in 1945 and became known as "The Revenue Stabilization Law of
Arkansas"; and

WHEREAS, Mr. Julian Hogan was a true public servant who carried out his
responsibilities with quiet competence, humility, and expertise and who

enjoyed a legendary reputation, not only for his honesty and integrity, but for his total understanding and unexcelled skill in matters relating to state finance; and

WHEREAS, Mr. Julian Hogan was truly a unique public servant whose influence on Arkansas government and particularly public finances in Arkansas has endured and will continue to endure for many decades to come,

NOW THEREFORE,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

That this Resolution is adopted in respectful memory of Mr. Julian C. Hogan, and in recognition of his many years of outstanding and dedicated public service to the State of Arkansas and the exceptionally beneficial influence his service and his ideas have had and will continue to have on state government finances in Arkansas.

BE IT FURTHER RESOLVED that upon adoption of this Resolution a copy shall be transmitted to Mrs. Marie B. Hogan, the widow of Mr. Julian C. Hogan.
