For An Act To Be Entitled

7 "AN ACT TO REENACT SECTION 8 OF ACT 16 OF THE FIRST
8 EXTRAORDINARY SESSION OF 1981 REGARDING THE COURT
9 REPORTERS' FUND IN ORDER TO CODIFY THE SAME IN THE
10 ARKANSAS CODE SINCE IT WAS OMITTED FROM THE ARKANSAS CODE;
11 AND FOR OTHER PURPOSES."

14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16 SECTION 1. Section 8 of Act 16 of the First Extraordinary Session of
17 1981 is hereby amended to read as follows:

18 "Section 8. If during any month moneys in the Court Reporters' Fund in
19 the State Treasury are inadequate to pay salaries and expenses as authorized
20 by law of the various court reporters of the State, then upon certification
21 thereof by the Chief Fiscal Officer of the State, the State Treasurer shall
22 transfer to the Court Reporters' Fund from the County Aid Fund general revenue
23 turnback funds such additional amounts as may be necessary to make such
24 payments of salaries and expenses of the court reporters. The amounts so
25 transferred shall be considered a temporary loan from the County Aid Fund to
26 be repaid on or before the end of the fiscal year from funds available
27 therefor, if any, in the Court Reporters' Fund. If at the end of any fiscal
28 year there are not adequate funds in the Court Reporters' Fund to repay the
29 full amount of loans made from the County Aid Fund to the Court Reporters'
30 Fund during said fiscal year, the Chief Fiscal Officer of the State shall
31 certify such fact to the State Treasurer and the State Treasurer shall write
32 the same off the books as a permanent transfer from the County Aid Fund to the
33 Court Reporters' Fund. It is the intent of this Section that if during any
34 fiscal year it is necessary to transfer funds from the County Aid Fund to the
35 Court Reporters' Fund to provide moneys for the payment of the salaries and

1 expense allowances provided herein for court reporters, and if during such
2 fiscal year funds in the Court Reporters' Fund are not adequate to make
3 repayment to the County Aid Fund, the amount so transferred to the Court
4 Reporters' Fund from the County Aid Fund during that fiscal year shall be
5 considered a direct cost to county government to be charged against general
6 revenue turnback to the counties for such year."

7

8 SECTION 2. All provisions of this Act of a general and permanent nature
9 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
10 Revision Commission shall incorporate the same in the Code.

11

12 SECTION 3. If any provision of this Act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the Act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 Act are declared to be severable.

17

18 SECTION 4. All laws and parts of laws in conflict with this Act are
19 hereby repealed.
