7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED §7-1-101(7) TO
9 PROVIDE THAT MINORITY PARTY MEMBERS OF BOARDS AND
10 COMMISSIONS SHALL BE SELECTED FROM A LIST OF NOT LESS THAN
11 FIVE NAMES SUBMITTED TO THE APPOINTING OFFICIALS BY THE
12 STATE CHAIRMAN OF THE MINORITY PARTY; AND FOR OTHER
13 PURPOSES."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. Arkansas Code Annotated §7-1-101(7) is amended to read as
18 follows:

19 "(7) 'Minority party' means that political party whose candidates were
20 elected to less than a majority of the constitutional offices of this state in
21 the last preceding general election or the political party which polled the
22 second greatest number of votes for the office of Governor in the last
23 preceding general election if all of the elected constitutional officers of
24 this state are from a single political party. Whenever the membership of any
25 Board or Commission requires the selection of a representative of the minority
26 party, the appointing official or officials shall make their appointment from
27 a list of not less than five (5) names submitted to them by the State Chairman
28 of the minority political party. *If for any reason there is not a name*
29 *acceptable to the appointing official contained in the first five (5) names*
30 *submitted, additional names may be requested. However, once a total of ten*
31 *(10) names has been submitted to the appointing official by the State Chairman*
32 *of the minority political party, the selection and appointment shall be made*
33 *from that list of names.*"

35 SECTION 2. All provisions of this act of a general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
2 Revision Commission shall incorporate the same in the Code.

4 SECTION 3. If any provision of this act or the application thereof to
5 any person or circumstance is held invalid, such invalidity shall not affect
6 other provisions or applications of the act which can be given effect without
7 the invalid provision or application, and to this end the provisions of this
8 act are declared to be severable.

9

10 SECTION 4. All laws and parts of laws in conflict with this act are
11 hereby repealed.
