For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE 21-2-705(c) CONCERNING
8 MEETINGS OF THE GOVERNMENTAL BONDING BOARD; TO REPEAL
9 OBSOLETE LAWS; AND FOR OTHER PURPOSES."

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14 SECTION 1. Arkansas Code 21-2-705(c)(1) is amended to read as follows:
15 "(c)(1) The board shall meet at least quarterly. However, if there are
16 no proof of losses or other business for the board to consider, the chairman
17 may cancel a regularly scheduled quarterly meeting upon written notice to the
18 members. The board shall also meet at any other time as necessary to carry out
19 its responsibilities and duties, at the call of the chairman, or upon the
20 request of a majority of the board."

21

22 SECTION 2. Arkansas Code 21-2-705(c) is amended by adding a new
23 subsection to read as follows:

24 "(3) If a board member is unable to attend any board meeting, the
25 member shall appoint a designee to act as his or her representative. The
26 representative shall have all the rights and privileges of the member they
27 represent."

29 SECTION 3. (a) The following provisions of the Arkansas Code are
30 repealed:

31 (1) §21-2-201 through §21-2-211 concerning the School District
32 Public Employees Bond Advisory Committee;
33 (2) §21-2-301 through §21-2-311 concerning the Municipal Public
34 Employees Bond Advisory Committee;
35 (3) §21-2-401 through §21-2-411 concerning the County Public

1 Employees Bond Advisory Committee;
2 (4) §21-2-501 through §21-2-509 concerning the State Public
3 Employees Bond Advisory Committee; and
4 (5) §21-2-601 through §21-2-613 concerning the Public Employees
5 Bond Advisory Committee.

6 (b) All other laws and parts of laws in conflict with this act are
7 hereby repealed.

8

9 SECTION 4. All provisions of this act of a general and permanent nature
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
11 Revision Commission shall incorporate the same in the Code.

12

13 SECTION 5. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.
