HOUSE BILL 1348

For An Act To Be Entitled

8 "AN ACT TO AMEND ARK. CODE ANN. §14-236-106 TO PROVIDE
9 THAT ANY PERSON VIOLATING THE ARKANSAS SEWAGE DISPOSAL
10 SYSTEMS ACT SHALL, UPON CONVICTION, BE DEEMED GUILTY OF A
11 MISDEMEANOR; TO AMEND ARK. CODE ANN. §14-236-116
12 PERTAINING TO PERMIT AND REGISTRATION FEES UNDER THE
13 ARKANSAS SEWAGE DISPOSAL SYSTEMS ACT; AND FOR OTHER
14 PURPOSES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Ark. Code Ann. §14-236-106(c) is hereby amended to read as
19 follows:

20 "(c) Any person, firm, corporation, or association, *with the exception*
21 *of the homeowner*, who violates any of the provisions of this chapter or any
22 rules and regulations promulgated under the authority of this chapter shall,
23 upon conviction, be deemed guilty of a misdemeanor and shall be punished by a
24 fine of not less than one hundred dollars (\$100) nor more than five hundred
25 dollars (\$500) or by imprisonment not exceeding one (1) month, or both."

26

27 SECTION 2. Ark. Code Ann. 14-236-116 is hereby amended to read as
28 follows:

29 "14-236-116. Permit and registration fees - Annual training course.

30 (a) A fee of *thirty dollars (\$30.00)* shall be levied for the review of
31 individual sewage disposal permit applications . However, it shall not be
32 necessary to pay an additional fee to obtain a permit to repair an individual
33 sewage disposal system or alternate and experimental system installed under a
34 permit for which a fee has been paid under the provisions of this chapter.

35 (b) A fee of fifty dollars (\$50.00) shall be levied annually for the

1 registration of installers.

2 (c) A fee of one hundred dollars (\$100) shall be levied annually for
3 the registration of septic tank manufacturers.

4 (d) A designated representative must attend at least one (1) annual
5 training course provided by the Department of Health and pay a fifty dollar
6 (\$50.00) fee annually to maintain certification.

7 (e) The fee for the issuance of a review certificate under the
8 provisions of this chapter to the person developing a subdivision shall be a
9 minimum of *thirty dollars (\$30.00)* for one (1) lot and five dollars (\$5.00)
10 for each following lot, with a maximum of five hundred dollars (\$500).

11 (f) Permit and regulation fees collected under this chapter shall be
12 deposited in the State Treasury as follows:

13 (1) Five dollars (\$5.00) of each permit fee collected for permits
14 issued under subsection (a) of this section shall be credited to a special
15 fund to be known as the 'Individual Sewage Disposal Systems Improvement Fund',
16 which is established on the books of the State Treasurer, with such moneys to
17 be used by the Division of Sanitarian Services of the Department of Health
18 for, and in the manner recommended by the Advisory Committee on Individual
19 Sewage Disposal Systems, the implementation of the utilization and application
20 of alternate and experimental individual sewage disposal systems, as set forth
21 in this chapter.

22 (2) The remainder of the fees collected for permits issued under
23 the provisions of subsection (a) of this section, and all of the net fees
24 collected under the provisions of 14-236-112(c) and subdivisions (b) and (e)
25 of this section shall be credited to the Public Health Fund, and the moneys
26 shall be used only for the operation of the Division of Sanitarian Services of
27 the Department of Health; and

28 (3) Subject to such rules and regulations as may be implemented
29 by the Chief Fiscal Officer of the State, the disbursing officer for the
30 Department of Health is hereby authorized to transfer all unexpended funds
31 relative to the funds outlined in subdivision (f) (2) of this section that
32 pertain to fees collected, as certified by the Chief Fiscal Officer of the
33 State, to be carried forward and made available for expenditures for the same
34 purpose for any following fiscal year; and

35 (g) (1) Permits issued under subsections (b), (c) and (d) of this

1 section shall be nontransferable and shall be renewed annually.

2 (2) A late fee equal to one-half (1/2) of the renewal fee for any
3 type of registration or certification shall be charged to renew a permit sixty
4 (60) days after the annual expiration date."

5

6 SECTION 3. All provisions of this act of a general and permanent nature
7 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
8 Revision Commission shall incorporate the same in the Code.

9

10 SECTION 4. If any provision of this Act or the application thereof to
11 any person or circumstance is held invalid, such invalidity shall not affect
12 other provisions or applications of the Act which can be given effect without
13 the invalid provision or application, and to this end the provisions of this
14 Act are declared to be severable.

15

16 SECTION 5. All laws and parts of laws in conflict with this act are
17 hereby repealed.
