7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR OPERATING EXPENSES
9 AND GRANTS FOR THE DEPARTMENT OF FINANCE AND
10 ADMINISTRATION WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION
11 TO THOSE FUNDS APPROPRIATED BY ACTS 91 AND 247 OF THE
12 FIRST EXTRAORDINARY SESSION OF 1989, AND BY ACT 16 OF THE
13 THIRD EXTRAORDINARY SESSION OF 1989, FOR THE FISCAL YEAR
14 ENDING JUNE 30, 1991; AND FOR OTHER PURPOSES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. APPROPRIATIONS - DISASTER ASSISTANCE GRANTS. There is
19 hereby appropriated, to the Department of Finance and Administration -
20 Disbursing Officer, to be payable from the Disaster Assistance Fund, for
21 Disaster Grants of the Department of Finance and Administration - Disbursing
22 Officer which shall be supplemental and in addition to those funds
23 appropriated in Section 1 of Act 91 of the First Extraordinary Session of
24 1989, for the remainder of the fiscal year ending June 30, 1991, the
25 following:

31 SECTION 2. APPROPRIATIONS - MANAGEMENT SERVICES - MARKETING AND
32 REDISTRIBUTION. There is hereby appropriated, to the Department of Finance
33 and Administration, to be payable from the Property Sales Holding Fund, for
34 operating expenses of the Department of Finance and Administration which shall
35 be supplemental and in addition to those funds appropriated in Section 5 of

1 Act 247 of the First Extraordinary Session of 1989, for the remainder of the
 2 fiscal year ending June 30, 1991, the following:

15 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the
 16 Department of Finance and Administration - Division of Racing, to be payable
 17 from the State Central Services Fund, for operating expenses of the Department
 18 of Finance and Administration - Division of Racing which shall be supplemental
 19 and in addition to those funds appropriated in Section 2 of Act 16 of the
 20 Third Extraordinary Session of 1989, for the remainder of the fiscal year
 21 ending June 30, 1991, the following:

34 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 35 authorized by this Act shall be limited to the appropriation for such agency

1 and funds made available by law for the support of such appropriations; and
2 the restrictions of the State Purchasing Law, the General Accounting and
3 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
4 Procedures and Restrictions Act, or their successors, and other fiscal control
5 laws of this State, where applicable, and regulations promulgated by the
6 Department of Finance and Administration, as authorized by law, shall be
7 strictly complied with in disbursement of said funds.

8

9 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General
10 Assembly that any funds disbursed under the authority of the appropriations
11 contained in this Act shall be in compliance with the stated reasons for which
12 this Act was adopted, as evidenced by the Agency Requests, Executive
13 Recommendations and Legislative Recommendations contained in the budget
14 manuals prepared by the Department of Finance and Administration, letters, or
15 summarized oral testimony in the official minutes of the Arkansas Legislative
16 Council or Joint Budget Committee which relate to its passage and adoption.

18 SECTION 6. CODE. All provisions of this Act of a general and permanent
19 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
20 Code Revision Commission shall incorporate the same in the Code.

21

22 SECTION 7. SEVERABILITY. If any provision of this Act or the
23 application thereof to any person or circumstance is held invalid, such
24 invalidity shall not affect other provisions or applications of the Act which
25 can be given effect without the invalid provision or application, and to this
26 end the provisions of this Act are declared to be severable.

27

28 SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict
29 with this Act are hereby repealed.

30

31 SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the
32 Seventy-Eighth General Assembly, that funds provided by the Seventy-Seventh
33 General Assembly for the operations of the Department of Finance and
34 Administration are, due to unforeseen circumstances, insufficient for the
35 Department of Finance and Administration to continue to provide essential

1 governmental services; that the provisions of this act will provide the
2 necessary monies for the Department of Finance and Administration to continue
3 such services; and that a delay in the effective date of this Act could work
4 irreparable harm upon the proper administration and provision of essential
5 governmental programs. Therefore, an emergency is hereby declared to exist
6 and this Act being necessary for the immediate preservation of the public
7 peace, health and safety shall be in full force and effect from and after the
8 date of its passage and approval.
