For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF LABOR -
10 EMPLOYMENT SECURITY DIVISION FOR THE BIENNIAL PERIOD
11 ENDING JUNE 30, 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
16 for the Department of Labor - Employment Security Division for the 1991-93
17 biennium, the following maximum number of regular employees whose salaries
18 shall be governed by the provisions of the Uniform Classification and
19 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
20 laws amendatory thereto. Provided, however, that any position to which a
21 specific maximum annual salary is set out herein in dollars, shall be exempt
22 from the provisions of said Uniform Classification and Compensation Act. All
23 persons occupying positions authorized herein are hereby governed by the
24 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
25 Code §21-5-101), or its successor.

SECTION 2. EXTRA HELP. There is hereby authorized, for the Department of Labor - Employment Security Division for the 1991-93 biennium, the

1 following maximum number of part-time or temporary employees, to be known as
 2 "Extra Help", payable from funds appropriated herein for such purposes: four
 3 hundred (400) temporary or part-time employees, when needed, at rates of pay
 4 not to exceed those provided in the Uniform Classification and Compensation
 5 Act, or its successor, for the appropriate classification. Any of these
 6 positions utilized in a manner which are funded by federal sources are
 7 specifically exempt from limitation of hours, either by Act or Regulation.

 9 SECTION 3. APPROPRIATIONS - OPERATIONS. There is hereby appropriated,

5 SECTION 4. "REED ACT FUNDS". There is hereby appropriated out of funds
6 made available to this State under Section 903 of the Social Security Act, as
7 amended, the sum of \$5,000,000, or so much thereof as may be necessary, to be
8 used, under the direction of the Employment Security Division, for the purpose
9 of construction and improvement of buildings, rent/lease costs, acquisition of
10 data processing equipment, acquisition of land and/or for the payment of
11 salaries and related benefits of local office staff of the Employment Security
12 Division for the biennial period ending June 30, 1993.

14 The amount obligated pursuant to this Act shall not exceed the amount by which
15 (a) the aggregate of the amounts transferred to the account of this State
16 pursuant to Section 903 of the Social Security Act exceeds (b) the aggregate
17 of the amounts used by this State and charged against the amounts transferred
18 to the account of this State.

SECTION 14. ADDITIONAL POSITIONS. The Administrator of the Employment Security Division, after receiving the approval of the Office of Personnel Management, and after seeking the prior review by the Arkansas Legislative Council, shall have the authority to establish such new or additional full time positions as may become necessary to carry out the objectives of the program and/or to meet Federal requirements of new and/or expanded programs where such needs are financed by federal funds; provided that not more than two hundred persons may be employed in addition to those authorized in the salary schedule and that the rate of pay shall not exceed those set out in the salary schedule for comparable positions as authorized under the provisions of Section 1 of this Act.

SECTION 15. TRANSFER OF APPROPRIATION. Subject to such rules and regulations as may be implemented by the Chief Fiscal Officer of the State and after having sought the prior review by the Arkansas Legislative Council, the Administrator of the Employment Security Division is hereby authorized to make transfers from any appropriation made by this Act to any other appropriation made by this Act with the exception of the "Reed Act Funds" appropriations set forth in Section 4 of this Act, and of the appropriation made for Regular Salaries or Maintenance and General Operation. Such transfers may be made whenever it appears, by projecting the expenditures of any of the appropriations in this Act, that there will be a deficiency of appropriation in one item and that there will be a corresponding excess of appropriation in another item or items which may be transferred. The transfer of appropriation shall be effected only on approval of the Chief Fiscal Officer of the State. Provided, however, that no transfer of appropriations may be authorized to increase the total amount appropriated for Regular Salaries, or Maintenance and General Operations, except as may be authorized elsewhere by law.

SECTION 16. CARRY FORWARD. Any unexpended balance of appropriation made by this Act, with the exception of appropriation made for Regular Salaries and Maintenance and General Operation, which remains at the close of the fiscal year ending June 30, 1992, shall be transferred forward and made available for the same purpose for the fiscal year ending June 30, 1993.

SECTION 17. REPORTING. The Employment Security Division shall report quarterly to the Arkansas Legislative Council the number of registrants or recipients of Food Stamps interviewed, the number of job referrals made, and the number of registrants or recipients of Food Stamps placed in jobs. This report shall be made for each county or district office; provided the Employment Security Division has federal funds available and specifically identified for use in providing such services.

SECTION 18. RESTRICTIONS. Upon approval and implementation of the Office of Personnel Management's (OPM) classification recommendations of September 17, 1984, to be effective July 1, 1985, incumbents who occupied specified positions in the following recommended classifications or titles on

1 or before September 17, 1984, and who remain in those classifications and/or
 2 specified positions, shall continue to be paid at the grade authorized for
 3 that classification and position which was in effect on June 30, 1985.
 4 Employees who entered these classifications and/or specified positions after
 5 September 17, 1984, shall be paid at the OPM recommended classification and
 6 pay grade, as specified below:

SECTION 24. HEALTH PREMIUMS. The Department of Labor - Employment Security Division shall not, during the 1992-93 fiscal year, spend more for health insurance per employee than the amount being contributed to the State Employees Health Insurance Program.

SECTION 25. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Eighth General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1991 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1991 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1991.
