HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE STATE BANK DEPARTMENT FOR THE
10 BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR OTHER
11 PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. REGULAR SALARIES. There is hereby established for the State
16 Bank Department for the 1991-93 biennium, the following maximum number of
17 regular employees whose salaries shall be governed by the provisions of the
18 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et
19 seq.), or its successor, and all laws amendatory thereto. Provided, however,
20 that any position to which a specific maximum annual salary is set out herein
21 in dollars, shall be exempt from the provisions of said Uniform Classification
22 and Compensation Act. All persons occupying positions authorized herein are
23 hereby governed by the provisions of the Regular Salaries Procedures and
24 Restrictions Act (Arkansas Code §21-5-101), or its successor.

20 SECTION 2. EXTRA HELP. There is hereby authorized, for the State

21 Bank Department for the 1991-93 biennium, the following maximum number of

22 part-time or temporary employees, to be known as "Extra Help", payable from

23 funds appropriated herein for such purposes: Three (3) temporary or part-time

24 employees, when needed, at rates of pay not to exceed those provided in the

25 Uniform Classification and Compensation Act, or its successor, or this act for

26 the appropriate classification.

27

28 SECTION 3. APPROPRIATIONS. There is hereby appropriated, to the State

29 Bank Department, to be payable from the Bank Department Fund, for personal

30 services and operating expenses of the State Bank Department for the biennial

31 period ending June 30, 1993, the following:

13 SECTION 4. REGULAR SALARIES - CONTINGENCY. There is hereby established

14 for the State Bank Department - Contingency for the 1991-93 biennium, the

15 following maximum number of regular employees whose salaries shall be governed

16 by the provisions of the Uniform Classification and Compensation Act (Arkansas

17 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.

18 Provided, however, that any position to which a specific maximum annual salary

19 is set out herein in dollars, shall be exempt from the provisions of said

20 Uniform Classification and Compensation Act. All persons occupying positions

21 authorized herein are hereby governed by the provisions of the Regular

22 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its

23 successor.

33 SECTION 5. APPROPRIATIONS - CONTINGENCY. There is hereby appropriated,

34 to the State Bank Department - Contingency, to be payable from the Bank

17 SECTION 6. CONTINGENCY RESTRICTION. The appropriation for each line
18 item of the Bank-Contingency Program shall be held in deferred status until
19 released according to the provisions contained herein. In the event that the
20 number of institutions within the jurisdiction of the State Bank Department
21 increases through intrastate branching or interstate banking activities at a
22 rate that is deemed to require additional personnel and/or appropriation to
23 carry out the objectives of the Agency, the Director of the State Bank
24 Department is hereby authorized to request the Chief Fiscal Officer of the
25 State to approve a release from deferment of appropriations provided in
26 Section of this Act. Whenever the Director of the State Bank Department deems
27 it necessary to request a release of deferment as authorized herein, he shall
28 file with the Chief Fiscal Officer a written report accompanied by necessary
29 supporting documents setting forth the facts, justifications, and
30 circumstances that necessitate such request. Upon receipt of such reports and
31 supporting documents, the Chief Fiscal Officer shall study the same, and if he
32 shall determine that such release of deferred appropriation is being sought in
33 strict compliance with this Act, the Chief Fiscal Officer, after prior review
34 by the Arkansas Legislative Council or the Joint Budget Committee, may approve
35 or modify such request as in his judgment he deems necessary.

2 SECTION 7. SPECIAL RATES OF PAY. Due to the highly competitive job
3 market conditions for banking industry professionals and the necessity of
4 recruiting and retaining qualified personnel, the State Bank Department is
5 authorized special rates of pay for current and new employees up to the levels
6 listed under subsection (a), with additional authority and restrictions as
7 indicated in subsection (b) and (c) below:

8 (a) Special rates may be authorized for the following classifications
9 only, as indicated herein.

25 (b) Applications for special rates of pay above the bands indicated in
26 subsection (a) shall have been reviewed and approved by the Office of
27 Personnel Management after prior review by the Arkansas Legislative Council.

28 (c) This special provision shall be in full force and effect for the
29 biennium beginning July 1, 1991, and ending June 30, 1993.

30

31 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
32 authorized by this Act shall be limited to the appropriation for such agency
33 and funds made available by law for the support of such appropriations; and
34 the restrictions of the State Purchasing Law, the General Accounting and
35 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1 Procedures and Restrictions Act, or their successors, and other fiscal control
2 laws of this State, where applicable, and regulations promulgated by the
3 Department of Finance and Administration, as authorized by law, shall be
4 strictly complied with in disbursement of said funds.

5

6 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
7 Assembly that any funds disbursed under the authority of the appropriations
8 contained in this Act shall be in compliance with the stated reasons for which
9 this Act was adopted, as evidenced by the Agency Requests, Executive
10 Recommendations and Legislative Recommendations contained in the budget
11 manuals prepared by the Department of Finance and Administration, letters, or
12 summarized oral testimony in the official minutes of the Arkansas Legislative
13 Council or Joint Budget Committee which relate to its passage and adoption.

14

15 SECTION 10. CODE. All provisions of this Act of a general and
16 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
17 the Arkansas Code Revision Commission shall incorporate the same in the Code.

18

19 SECTION 11. SEVERABILITY. If any provision of this Act or the
20 application thereof to any person or circumstance is held invalid, such
21 invalidity shall not affect other provisions or applications of the Act which
22 can be given effect without the invalid provision or application, and to this
23 end the provisions of this Act are declared to be severable.

24

25 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict
26 with this Act are hereby repealed.

27

28 SECTION 13. HEALTH PREMIUMS. The State Bank Department shall not,
29 during the 1992-93 fiscal year, spend more for health insurance per employee
30 than the amount being contributed to the State Employees Health Insurance
31 Program.

32

33 SECTION 14. EMERGENCY CLAUSE. It is hereby found and determined by the
34 Seventy-Eighth General Assembly, that the Constitution of the State of
35 Arkansas prohibits the appropriation of funds for more than a two (2) year

1 period; that the effectiveness of this Act on July 1, 1991 is essential to the
2 operation of the agency for which the appropriations in this Act are provided,
3 and that in the event of an extension of the Regular Session, the delay in the
4 effective date of this Act beyond July 1, 1991 could work irreparable harm
5 upon the proper administration and provision of essential governmental
6 programs. Therefore, an emergency is hereby declared to exist and this Act
7 being necessary for the immediate preservation of the public peace, health and
8 safety shall be in full force and effect from and after July 1, 1991.
