For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE ARKANSAS INDUSTRIAL DEVELOPMENT
10 COMMISSION FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1993;
11 AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. REGULAR SALARIES - STATE. There is hereby established for
16 the Arkansas Industrial Development Commission - State for the 1991-93
17 biennium, the following maximum number of regular employees whose salaries
18 shall be governed by the provisions of the Uniform Classification and
19 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
20 laws amendatory thereto. Provided, however, that any position to which a
21 specific maximum annual salary is set out herein in dollars, shall be exempt
22 from the provisions of said Uniform Classification and Compensation Act. All
23 persons occupying positions authorized herein are hereby governed by the
24 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
25 Code §21-5-101), or its successor.

10 SECTION 28. TRANSFER PROVISION. If at any time during the 1991-93
 11 biennium, savings are accomplished in the appropriation provided for "European

23 SECTION 34. It is the intent of the General Assembly that the Arkansas
24 Industrial Development Commission work to establish the following
25 recommendations within the constraints of this appropriation:

26 (a) Identify problem areas within the State that are not conducive or
27 compatible to industrial growth and development.

28 (b) Create a special task force to target those problem areas and
29 attempt to rectify the problems.

30 (c) Establish a data base of regional industrial cross-references of
31 various industries within each county, such as industrial purchasing data,
32 demographics, geographics, etc., and maintain the data on a county by county
33 basis.

34 (d) Establish a statewide master computer linkage to access computer
35 data bases maintained by State agencies and institutions as well as private

1 entities, and to facilitate communication between local communities, higher
2 education institutions, the Arkansas Industrial Development Commission and
3 other appropriate entities.

4 (e) Stress self-help efforts on the local level.

5 (f) Develop a plan for industrial growth and development from within the
6 State.

7 (g) Enhance the lines of communication among existing industrial
8 development programs.

9 (h) Initiate pilot projects to act as the seeds for industrial
10 development within Arkansas.

11 (i) Address the problems of educational deficiencies, job skill
12 deficiencies, transportation deficiencies and basic needs within this State on
13 a statewide level as well as local and regional levels.

14

15 SECTION 35. After receiving approval from the Chief Fiscal Officer of
16 the State, the Director of the Arkansas Industrial Development Commission is
17 authorized to transfer appropriation from any line item appropriation provided
18 by Sections 3, 5, 7, 8, 10, 11, and 12 herein, to the appropriation provided
19 the Motion Picture Development Office in Section 7, in order to provide
20 sufficient appropriation for the State Economic Developer I and Administrative
21 Assistant II positions authorized in Section 6 of this Act.

22

23 SECTION 36. SPECIAL RATES OF PAY. Due to highly competitive job
24 market conditions for Industrial and Economic Development Professionals, and
25 the necessity of recruiting and retaining qualified personnel, the Arkansas
26 Industrial Development Commission is authorized special rates of pay for
27 current and new employees up to levels listed under subsection (b) below.
28 Special rates of pay may be requested subject to the following restrictions:

6 *SECTION 37. TRANSFER PROVISION - FOREIGN OFFICES. If at any time*
7 *during the 1991-93 biennium, the Director determines that market conditions*
8 *warrant, the Arkansas Industrial Development Commission is hereby authorized*
9 *to transfer, after receiving the approval of the Chief Fiscal Officer of the*
10 *State, from the appropriation for "European Trade" in Section 3 of this Act to*
11 *the appropriation for "Far East Trade/Industrial Recruitment" in Section 3 of*
12 *this Act, and from the appropriation for "Far East Trade/Industrial*
13 *Recruitment" in Section 3 of this Act to the appropriation for "European*
14 *Trade" in Section 3 of this Act. Such transfer shall be for the purpose of*
15 *responding to changes in the world markets.*

16

17 *SECTION 38. COMPLIANCE WITH OTHER LAWS. Disbursement of funds*
18 *authorized by this Act shall be limited to the appropriation for such agency*
19 *and funds made available by law for the support of such appropriations; and*
20 *the restrictions of the State Purchasing Law, the General Accounting and*
21 *Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary*
22 *Procedures and Restrictions Act, or their successors, and other fiscal control*
23 *laws of this State, where applicable, and regulations promulgated by the*
24 *Department of Finance and Administration, as authorized by law, shall be*
25 *strictly complied with in disbursement of said funds.*

27 *SECTION 39. LEGISLATIVE INTENT. It is the intent of the General*
28 *Assembly that any funds disbursed under the authority of the appropriations*
29 *contained in this Act shall be in compliance with the stated reasons for which*
30 *this Act was adopted, as evidenced by the Agency Requests, Executive*
31 *Recommendations and Legislative Recommendations contained in the budget*
32 *manuals prepared by the Department of Finance and Administration, letters, or*
33 *summarized oral testimony in the official minutes of the Arkansas Legislative*
34 *Council or Joint Budget Committee which relate to its passage and adoption.*

35

1 SECTION 40. CODE. All provisions of this Act of a general and
2 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
3 the Arkansas Code Revision Commission shall incorporate the same in the Code.
4

5 SECTION 41. SEVERABILITY. If any provision of this Act or the
6 application thereof to any person or circumstance is held invalid, such
7 invalidity shall not affect other provisions or applications of the Act which
8 can be given effect without the invalid provision or application, and to this
9 end the provisions of this Act are declared to be severable.

10

11 SECTION 42. GENERAL REPEALER. All laws and parts of laws in conflict
12 with this Act are hereby repealed.

13

14 SECTION 43. HEALTH PREMIUMS. The Arkansas Industrial Development
15 Commission shall not, during the 1992-93 fiscal year, spend more for health
16 insurance per employee than the amount being contributed to the State
17 Employees Health Insurance Program.

18

19 SECTION 44. EMERGENCY CLAUSE. It is hereby found and determined by the
20 Seventy-Eighth General Assembly, that the Constitution of the State of
21 Arkansas prohibits the appropriation of funds for more than a two (2) year
22 period; that the effectiveness of this Act on July 1, 1991 is essential to the
23 operation of the agency for which the appropriations in this Act are provided,
24 and that in the event of an extension of the Regular Session, the delay in the
25 effective date of this Act beyond July 1, 1991 could work irreparable harm
26 upon the proper administration and provision of essential governmental
27 programs. Therefore, an emergency is hereby declared to exist and this Act
28 being necessary for the immediate preservation of the public peace, health and
29 safety shall be in full force and effect from and after July 1, 1991.
