10 by all persons convicted of, or who plead guilty or nolo contendere to,
11 felonies, misdemeanors, or traffic violation for violation of state law or
12 local ordinance, or any person committed to the county jail in the circuit,

Prosecuting and city attorneys. - 8 "(a) To provide funds for the retirement benefits provided in this
- 9 subchapter, costs, in addition to the costs now provided by law, shall be
- 10 assessed as follows:
- 11 (1) A fee of one dollar (\$1.00) for entering upon the records of
- 12 the court each conviction, plea of guilty, plea of nolo contendere, and bond

- 23 each plea of guilty or nolo contendere, of a traffic violation, where the
- 24 conviction arises out of the operation of a motor vehicle in violation of
- 25 municipal ordinances or the laws of this state.
- 26 (2) This penalty shall also apply to each conviction, plea of
- 27 guilty or nolo contendere, for the violation of municipal ordinances or a
- 28 criminal law of this state.
- 29 (b) For the purposes of this subchapter, the term conviction shall
- 30 include forfeiture of bond. Any bond posted pursuant to a charge or citation

SECTION 19. Arkansas Code Annotated §16-68-409(b)(2) is hereby 2 repealed. 3 SECTION 20. The costs set forth in this act may be imposed at the 5 conclusion of any criminal case that does not end in an acquittal, dismissal, 6 or, with the consent of the prosecution, a nolle prosequi, including, but not 7 limited to, cases involving a suspended or probated sentence that at any time 8 may be expunged or otherwise removed from the defendant's record. 9 SECTION 21. Time pay account alternative. Arkansas Code Annotated §16-10 11 10-209(5)(F) is hereby amended to read as follows: "(F)(1) All time payments shall initially be deemed to be collections 12 13 of court costs until the costs have been collected in full, with any remaining 14 time payments representing collections of fines. The court clerk shall prepare 15 at least monthly a separate court report for all time payments made on 16 accounts. The monetary settlement for this separate court report shall be made 17 on or before the fifth day of the next following month. No settlement shall 18 be made on any time payment account until all of the court costs applicable to 19 the account have been collected in full, except that court costs on DWI cases 20 may be settled as collected. Any subsequent collections on the time payment 21 account, representing fines collected, shall be settled on the appropriate 22 court report as they are collected. (2) A municipal or county governing body may provide by appropriate 23 24 municipal or county legislation an alternative method of time payment 25 allocation as follows: (a) All time payments shall be allocated fifty percent (50%) to 26 27 court cost and fifty percent (50%) to fines. Whenever either court costs or 28 fines are fully paid, all remaining time payments shall be allocated to

29 remaining amounts due.30 (b) The court cle

30 (b) The court clerk shall prepare at least monthly a separate
31 court report for all time payments made on accounts. The monetary settlement
32 for this separate court report shall be made on or before the fifth day the
33 next following month."

35 SECTION 22. Legislative Findings. It is hereby found that the passage

- 1 of many court cost bills over several legislative sessions has caused
- 2 confusion in the collection of such costs and that reasonable people can
- 3 interpret the varying language of such court costs statutes differently. This
- 4 legislation is necessary to standardize the language of such court cost
- 5 statutes to provide that such costs are collected in a uniform manner
- 6 statewide.

8 SECTION 23. Act remedial in nature. This act is hereby declared to be

9 remedial in nature and is to be liberally construed to effect its purpose.

10

- 11 SECTION 24. Probation fees. Nothing herein shall prohibit courts from
- 12 assessing reasonable probation fees.

13

- 14 SECTION 25. Act amends the Arkansas Code of 1987 Annotated. All
- 15 provisions of this act of a general and permanent nature are amendatory to the
- 16 Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission
- 17 shall incorporate the same in the Code.

18

- 19 SECTION 26. Severability. If any provision of this act or the
- 20 application thereof to any person or circumstance is held invalid, such
- 21 invalidity shall not affect other provisions or applications of the act which
- 22 can be given effect without the invalid provision or application, and to this
- 23 end the provisions of this act are declared to be severable.

24

- 25 SECTION 27. Repealer. All laws and parts of laws in conflict with this
- 26 act are hereby repealed.

27

- 28 SECTION 28. EMERGENCY CLAUSE. It is hereby found and determined by the
- 29 General Assembly that the language of certain court cost statutes lacks
- 30 uniformity; that such lack of uniformity is detrimental to the proper
- 31 collection of such court costs; and that such language should be standardized
- 32 to promote the proper collection of such costs. Therefore, an emergency is
- 33 hereby declared to exist and this act being necessary for the immediate
- 34 preservation of the public peace, health and safety shall be in full force and
- 35 effect from and after its passage and approval.
