For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 14-234-304 TO PROVIDE THAT
9 SUCCESSOR MEMBERS OF MUNICIPAL WATERWORKS COMMISSIONS
10 SHALL BE APPOINTED BY THE GOVERNING BODY OF THE CITY AND
11 TO PROVIDE THAT VACANCIES OCCURRING ON THE COMMISSION
12 SHALL BE FILLED BY APPOINTMENT OF THE GOVERNING BODY OF
13 THE CITY; AND FOR OTHER PURPOSES."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. Arkansas Code 14-234-304 is hereby amended to read as
18 follows:

19 "14-234-304. Appointment of commissioners - Term - Salaries - Oath.

20 (a) (1) The commissioners shall be appointed by the mayor and confirmed
21 by a two-thirds (2/3) vote of the duly elected and qualified members of the
22 governing body of the city and shall hold office for a term of eight (8)
23 years.

24 (2) However, commissioners first appointed and confirmed shall serve
25 for terms of four (4), six (6), and eight (8) years each to be designated by
26 the mayor and the governing body of the city and thereafter, and upon the
27 expiration of their respective terms, their successors shall be appointed by
28 the governing body of the city for a term of eight (8) years.

29 (b) The governing body of the city shall have authority to fix and
30 prescribe the salaries to be paid to the commissioners.

31 (c) In the event of a vacancy occurring on the commission, it shall be
32 filled by appointment of the governing body of the city.

33 (d) The commissioners shall file the oath required by law in the State
34 of Arkansas of public officials."

35

1 SECTION 2. All provisions of this act of a general and permanent nature
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
3 Revision Commission shall incorporate the same in the Code.

4

5 SECTION 3. If any provision of this act or the application thereof to
6 any person or circumstance is held invalid, such invalidity shall not affect
7 other provisions or applications of the act which can be given effect without
8 the invalid provision or application, and to this end the provisions of this
9 act are declared to be severable.

10

11 SECTION 4. All laws and parts of laws in conflict with this act are
12 hereby repealed.
