## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 26-52-510 AND 26-52-126, AS  
9 THEY WERE AMENDED BY ACT 3 OF 1991, TO ALLOW A PERSON  
10 ENGAGED IN THE BUSINESS OF RENTING OR LEASING LICENSED  
11 MOTOR VEHICLES TO DEDUCT THE AMOUNT RECEIVED FROM THE SALE  
12 OF A MOTOR VEHICLE FROM THE CONSIDERATION PAID FOR A  
13 REPLACEMENT VEHICLE; AND FOR OTHER PURPOSES."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. Arkansas Code 26-52-510, as amended by Act 3 of 1991, is  
18 amended to add an additional subsection to read as follows:

19 "(f) *A person in the business of renting motor vehicles thirty (30)*  
20 *days or less and that collect the rental vehicle tax under §26-52-311 may*  
21 *claim a deduction from the sales price of a replacement vehicle equal to the*  
22 *lesser of either the sales price of the replaced vehicle or the fair market*  
23 *value of the replaced vehicle, if:*

24 (1) *The person resells the replaced vehicle within eighteen (18) months*  
25 *after its purchase;*

26 (2) *The person obtained the certificate of title to the replaced*  
27 *vehicle and used the replaced vehicle for rental;*

28 (3) *The person purchases the replacement vehicle within twelve (12)*  
29 *months after the resale of the replaced vehicle; and*

30 (4) *The person obtains the certificate of title to the replacement*  
31 *vehicle and uses the replacement vehicle for rental."*

33 SECTION 2. Arkansas Code 26-53-126, as amended by Act 3 of 1991, is  
34 amended to add an additional subsection to read as follows:

35 "(e) *A person in the business of renting motor vehicles thirty (30)*

1 days or less and that collect the rental vehicle tax under §26-52-311 may  
2 claim a deduction from the sales price of a replacement vehicle equal to the  
3 lesser of either the sales price of the replaced vehicle or the fair market  
4 value of the replaced vehicle, if:

5         (1) The person resells the replaced vehicle within eighteen (18) months  
6 after its purchase;

7         (2) The person obtained the certificate of title to the replaced  
8 vehicle and used the replaced vehicle for rental;

9         (3) The person purchases the replacement vehicle within twelve (12)  
10 months after the resale of the replaced vehicle; and

11         (4) The person obtains the certificate of title to the replacement  
12 vehicle and uses the replacement vehicle for rental."

14             SECTION 3. Every person claiming a deduction under this act shall keep  
15 adequate records from which the Director may verify the purchase, use and  
16 resale of all original and replacement motor vehicles; consideration received  
17 for replaced vehicles; and any other information required by the Arkansas Tax  
18 Procedure Act, Ark. Code Ann. §26-18-101 et seq.

20             SECTION 4. All provisions of this act of a general and permanent  
21 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
22 Code Revision Commission shall incorporate the same in the Code.

24             SECTION 5. If any provision of this act or the application thereof to  
25 any person or circumstance is held invalid, such invalidity shall not affect  
26 other provisions or applications of the act which can be given effect without  
27 the invalid provision or application, and to this end the provisions of this  
28 act are declared to be severable.

30             SECTION 6. All laws and parts of laws in conflict with this act are  
31 hereby repealed.
