For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE TITLE 19, CHAPTER 5, THE

9 REVENUE STABILIZATION LAW; AND FOR OTHER PURPOSES."

10

11 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

12

13 SECTION 1. Arkansas Code 19-5-205(e)(1)(B)(i) is hereby amended to read
14 as follows, to reflect current sources of special revenues to the State
15 Central Services Fund:

16 "(i) Those special revenues as specified in subdivisions (11), (19), (21),
17 (75), (76), (77), (78), (79), (80), (82), (83), (84), (85), (86), (87),
18 (88), (89), (90), (91), (92), (96), (112), (116), (118), (124), (131),
19 (149) and ten percent (10%) of those special revenues as set out in
20 subsection (20) of §19-6-301 of the Revenue Classification Law of
21 Arkansas, §19-6-101 et seq.;"

22

23 SECTION 2. Arkansas Code 19-5-303(s) is hereby amended to read as
24 follows:

25 "(s)(1) NORTHWEST ARKANSAS COMMUNITY COLLEGE FUND. There is hereby
26 established on the books of the State Treasurer, State Auditor, and
27 Chief Fiscal Officer of the State a fund to be known as the Northwest
28 Arkansas Community College Fund. This fund shall be used for the
29 maintenance, operation and improvement of the Northwest Arkansas
30 Community College.

31 (2) The fund shall consist of:

32 (A) Such general revenues as may be provided by law; and

33 (B) Any other funds made available for the support of the Northwest
34 Arkansas Community College, and which are required to be
35 deposited into the State Treasury by law."

SECTION 3. Arkansas Code 19-5-304(1)(B)(ii) is hereby amended to read as follows, to reflect current sources of revenues to the Vocational Education Administration Fund Account:

"(ii) The fund account shall consist of those general revenues as may be provided by the Revenue Stabilization Law."

SECTION 4. Arkansas Code 19-5-306(2)(B) is hereby amended to read as follows, to reflect current sources of income to the Developmental Disabilities Services Fund Account:

"(B) The fund account shall consist of:

- (i) Those general revenues as may be provided by law;
- (ii) Nonrevenue income derived by services provided by the human development centers;
- (iii) Funds received from local sources to provide matching for community developmental disabilities services programs; and
- (iv) Reimbursement received from the Division of Economic and Medical Services."

SECTION 5. Arkansas Code 19-5-307(b)(1) is hereby amended to read as follows, to reflect current sources of special revenue to the Public Health Fund:

"(1) Those special revenues as set out in subdivisions (65), (66), (69), (97), (133), (136), (137), (139), (140), (141), (142), (143), (144), (147), and (155) of §19-6-301 of the Revenue Classification Law;"

SECTION 6. Arkansas Code §19-5-602(a)(3) is hereby amended to read as follows, to reflect current sources of special revenue to the County Aid Fund:

"(3) Those special revenues as set out in Subdivisions (74), (117) and forty-five percent (45%) of those special revenues as specified in Subdivision (20) of §19-6-301 of the Revenue Classification Law; and"

SECTION 7. Arkansas Code 19-5-946 is hereby amended to read as follows:

"19-5-946. County Collectors Continuing Education Trust Fund. There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the

1 "County Collector's Continuing Education Trust Fund". Such fund shall
 2 consist of fees, as annually appropriated by the Quorum Court of each
 3 county, of the Office of County Collector and such funds withheld from
 4 the County Aid Fund for those counties which fail or refuse to provide
 5 such appropriated fees, there to be used exclusively for the
 6 establishment and operation of a continuing education program for county
 7 collectors and sheriff/collectors, as set out in §14-15-1001."

8
 9 SECTION 8. Arkansas Code 19-5-1004(b) (2) is hereby amended to read as
 10 follows:

11 "(2) The portion not determined to be special revenues by §19-6-110 of the
 12 year-end balances of the funds and fund accounts created in §§19-5-302,
 13 19-5-304 (1), (3), (4), (5), and (6), 19-5-306, 19-5-307, 19-6-404, and
 14 19-6-411, which fund balances are to be transferred on or before August
 15 15 of the fiscal year next following the fiscal year during which
 16 balances accrued. Provided, however, that the unspent balance of those
 17 funds used by the State Department of Higher Education under the
 18 provisions of §19-5-302 (7), appropriated and funded for the operation
 19 of the State Scholarship Assistance Grants Program and the
 20 Teacher/Administrator Grants Program, shall be exempt from the
 21 provisions of this subdivision and shall remain deposited in the
 22 Department of Higher Education Fund Account, and be carried forward,
 23 provided that such funds are used solely for providing financial aid
 24 grants for each year of the biennium. Provided further, a report of
 25 such balances which are authorized to be carried forward herein, as well
 26 as a summary of expenditures made from the State Scholarship Assistance
 27 Grants Program, shall be filed annually with the Arkansas Legislative
 28 Council. In addition, any funds which remain in the Vocational-
 29 Technical Schools Fund Account at the end of a fiscal year due to the
 30 provisions of this section, shall be transferred by the Chief Fiscal
 31 Officer of the State to the General Improvement Fund or its successor
 32 fund or fund accounts, there to be used exclusively to provide
 33 additional funding for appropriations for vocational-technical schools
 34 which are made payable from the General Improvement Fund or its
 35 successor fund or fund accounts."

SECTION 9. Arkansas Code 19-5-1025 is hereby amended to read as follows:

"19-5-1025. DHS CONSOLIDATED COST REVOLVING FUND. There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "DHS Consolidated Cost Revolving Fund". Such fund shall be used by the Department of Human Services, Division of Management Services for the purposes of providing a system to charge consolidated costs for such items as: postage, vehicle maintenance, vehicle insurance, vehicle license and title fees, tires and tubes, fuel, credit card purchases, office supplies, micrographic supplies, sales and use taxes, and various other licenses and permits. These items will be purchased by the Division of Management Services through the use of the revolving fund and charged to each Division and Office as that Division or Office uses it. This will allow for the expenditure to be appropriately charged to the benefiting program. The replenishment of the revolving fund will consist of such funds as budgeted by the division and offices for these items of cost which could be general revenue, special revenue, federal funds, cash funds or any other funds under the authority of the divisions and offices. Said account shall be replenished as needed but not less than six times per fiscal year. Said account shall be established and maintained in accordance with procedures established by the Chief Fiscal Officer of the State. The Department of Human Services shall have one time transfer authority to establish the DHS Consolidated Cost Revolving Fund. The initial transfer of funds to this account shall be made from the general revenue funds of the various Department of Human Services divisions and offices participating in the account."

SECTION 10. TRUST FUNDS. Arkansas Code Title 19, Chapter 5, Subchapter 9, is hereby amended by adding the following new Sections:

"19-5-957. Identification Pending Trust Fund for Local Sales and Use Taxes. There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the

1 "Identification Pending Trust Fund for Local Sales and Use Taxes". Such
 2 fund shall consist of money reported as local sales and use taxes which
 3 were collected in local taxing jurisdictions which are not immediately
 4 identifiable and money collected in local jurisdictions which have no
 5 tax, there to be used for transfers to the Local Sales and Use Tax Trust
 6 Fund when a local tax jurisdiction is identified for money and for
 7 transfers to general revenues when the total amount in this fund exceeds
 8 fifty thousand dollars (\$50,000), as set out in §§26-74-221 and 26-74-
 9 317.

10

11 19-5-958. Insurance Continuing Education Trust Fund.

12 There is hereby established on the books of the State Treasurer, State
 13 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 14 "Insurance Continuing Education Trust Fund". Such fund shall consist of
 15 certification filing fees as provided for in §23-64-306, there to be
 16 used for administering continuing education provisions for insurance
 17 agents, solicitors, consultants and brokers as set out in §23-64-301 et
 18 seq.

19

20 19-5-959. Petroleum Storage Tank Trust Fund.

21 There is hereby established on the books of the State Treasurer, State
 22 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 23 "Petroleum Storage Tank Trust Fund". Such fund shall consist of the
 24 Petroleum Environmental Assurance Fee as provided for in §8-7-906, that
 25 portion of annual registration fees as set out in §8-7-802(6), all other
 26 fees assessed under §8-7-901 et seq., and any monies recovered by the
 27 Department of Pollution Control and Ecology which are attributable to
 28 collections of civil penalties under §8-7-806 or to costs under §8-7-807
 29 not owed the Regulated Substance Storage Tank Program Fund, there to be
 30 administered by the Director of the Department of Pollution Control and
 31 Ecology who shall make disbursements from the fund as authorized by
 32 §8-7-901 et seq.

33

34 19-5-960. Private Career School Student Protection Trust Fund.

35 There is hereby established on the books of the State Treasurer, State

1 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
2 "Private Career School Student Protection Trust Fund". Such fund shall
3 consist of a fee to be set by the State Board of Private Career
4 Education as provided for in §6-51-607, there to be used for paying
5 claims and other expenses as set out in §6-51-607.

6
7 19-5-961. Solid Waste Management and Recycling Fund.

8 There is hereby established on the books of the State Treasurer, State
9 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
10 "Solid Waste Management and Recycling Fund". Such fund shall consist of
11 those special revenues as specified in Subdivision (154) of §19-6-301,
12 reimbursement of funds pursuant to §8-6-610, federal funds which may
13 become available, interest earnings, gifts, donations and any other
14 funds made available by the General Assembly, there to be administered
15 by the Department of Pollution Control and Ecology as set out in
16 §8-6-601 et seq.

17
18 19-5-962. State Health Department Building and Local Grant Trust Fund.
19 There is hereby established on the books of the State Treasurer, State
20 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
21 "State Health Department Building and Local Grant Trust Fund". Such
22 fund shall consist of funds transferred from the Department of Health
23 Expansion Revenue Bond Fund which are unnecessary for the orderly
24 payment of outstanding bonds or the provision of payment thereof and all
25 fees and other monies now required by law to be deposited into the State
26 Department of Health Revenue Bond Fund, §20-7-123, and any other monies
27 as may be authorized by law, there to be used for the purposes as
28 intended and authorized by law, including, but not limited to,
29 improvements and additions to the State Health Building and approved
30 projects to improve local health facilities, all as set out in §20-7-201
31 et seq.

32
33 19-5-963. War Memorial Stadium Improvement and Expansion Fund.

34 There is hereby established on the books of the State Treasurer, State
35 Auditor, and Chief Fiscal Officer of the State a fund to be known as the

1 "War Memorial Stadium Improvement and Expansion Fund". Such fund shall
2 consist of contributions made through state income tax refund checkoffs,
3 there to be used by the War Memorial Stadium Commission for War Memorial
4 Stadium improvement and expansion purposes, upon appropriation by the
5 General Assembly, as set out in §26-51-433.

6
7
8 19-5-964. Water Resources Development Bond Fund.

9 There is hereby established on the books of the State Treasurer, State
10 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
11 "Water Resources Development Bond Fund". Such fund shall consist of
12 proceeds from the sale of bonds as issued by the Arkansas Soil and Water
13 Conservation Commission and revenues derived from projects financed
14 under §15-22-601, in amounts or portions as set forth in the resolution
15 or trust indenture authorizing or securing such bonds; general revenues;
16 and any other funds made available by the General Assembly; there to be
17 used only to provide for payment of all or part of debt service on bonds
18 issued under §15-22-601, either at maturity or upon redemption prior to
19 maturity, as administered by the State Treasurer.

20
21 19-5-965. Water Resources Development Debt Service Reserve Fund.

22 There is hereby established on the books of the State Treasurer, State
23 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
24 "Water Resources Development Debt Service Reserve Fund". Such fund
25 shall consist of proceeds from the sale of bonds as issued by the
26 Arkansas Soil and Water Conservation Commission and revenues derived
27 from projects financed under § 15-22-601, in amounts or portions as set
28 forth in the resolution or trust indenture authorizing or securing such
29 bonds; general revenues, and any other funds made available by the
30 General Assembly; there to be used only to insure prompt payment of debt
31 service on bonds issued under §15-22-601, either at maturity or upon
32 redemption prior to maturity, as administered by the State Treasurer.

33
34 19-5-966. Water Resources Development Operation and Maintenance Fund.

35 There is hereby established on the books of the State Treasurer, State

1 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 2 "Water Resources Development Operation and Maintenance Fund". Such fund
 3 shall consist of proceeds from the sale of bonds as issued by the
 4 Arkansas Soil and Water Conservation Commission and revenues derived
 5 from projects financed under § 15-22-601, in amounts or portions as set
 6 forth in the resolution or trust indenture authorizing or securing such
 7 bonds, there to be used for all or a part of the operation and
 8 maintenance needs of projects financed under the provisions of §15-22-
 9 601.

10
 11 19-5-967. Water Resources Development Construction Fund.
 12 There is hereby established on the books of the State Treasurer, State
 13 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 14 "Water Resources Development Construction Fund". Such fund shall
 15 consist of proceeds from the sale of bonds as issued by the Arkansas
 16 Soil and Water Conservation Commission, there to be used, pursuant to
 17 appropriation by the General Assembly, for projects developed under §15-
 18 22-601.

19
 20 19-5-968. Waste Disposal and Pollution Abatement Facilities
 21 Construction Fund.
 22 There is hereby established on the books of the State Treasurer, State
 23 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 24 "Waste Disposal and Pollution Abatement Facilities Construction Fund".
 25 Such fund shall consist of proceeds from the sale of bonds as issued by
 26 the Arkansas Soil and Water Conservation Commission and revenues derived
 27 from projects financed under §15-22-701, in amounts or portions as set
 28 forth in the resolution or trust indenture authorizing or securing such
 29 bonds, there to be used for the development of projects and the payment
 30 of the costs and expenses of the issuance of the bonds.

31
 32 19-5-969. Waste Disposal and Pollution Abatement Facilities Bond Fund. There
 33 is hereby established on the books of the State Treasurer, State
 34 Auditor, and Chief Fiscal Officer of the State a fund to be known as
 35 the "Waste Disposal and Pollution Abatement Facilities Bond Fund". Such

fund shall consist of proceeds from the sale of bonds as issued by the Arkansas Soil and Water Commission and revenues derived from projects financed under §15-22-701, in amounts or portions as set forth in the resolution or trust indenture authorizing or securing such bonds; general revenues; and any other funds made available by the General Assembly; there to be used only to provide for payment of all or part of debt service on bonds issued under §15-22-701, either at maturity or upon redemption prior to maturity, as administered by the State Treasurer.

19-5-970. Waste Disposal and Pollution Abatement Facilities Debt Service Reserve Fund.

There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "Waste Disposal and Pollution Abatement Facilities Debt Service Reserve Fund".

Such fund shall consist of proceeds from the sale of bonds as issued by the Arkansas Soil and Water Conservation Commission and revenues derived from projects financed under §15-22-701, in amounts or portions as set forth in the resolution or trust indenture authorizing or securing such bonds; general revenues; and any other funds made available by the General Assembly; there to be used only to insure prompt payment of debt service on bonds issued under §15-22-701, either at maturity or upon redemption prior to maturity, as administered by the State Treasurer.

19-5-971. Waste Disposal and Pollution Abatement Facilities Operation and Maintenance Fund.

There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "Waste Disposal and Pollution Abatement Facilities Operation and Maintenance Fund". Such fund shall consist of proceeds from the sale of bonds as issued by the Arkansas Soil and Water Conservation Commission and revenues derived from projects financed under §15-22-701, in amounts or portions as set forth in the resolution or trust indenture authorizing or securing such bonds, there to be used for all or a part of the operation and maintenance of the projects financed under §15-22-

1 701 et seq.

2

3 19-5-972. Special State Assets Forfeiture Fund.

4 There is hereby established on the books of the State Treasurer, State
 5 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 6 "Special State Assets Forfeiture Fund". Such fund shall consist of
 7 revenues as provided in §5-64-505(k)(2)(iv) and any other revenues as
 8 may be provided by law, there to be administered through rules and
 9 regulations established by the State Drug Director in accordance with
 10 the intent and purposes of Subchapters 1-6 of Chapter 64, Title 5 of the
 11 Arkansas Code.

12

13 19-5-973. Public Facilities Construction Fund.

14 There is hereby established on the books of the State Treasurer, State
 15 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 16 "Public Facilities Construction Fund". Such fund shall consist of the
 17 remainder of the proceeds from the sale of certificates of indebtedness
 18 as provided in §22-3-1214, there to be used only for the redemption of
 19 the 1977 Bonds and the 1979 Bonds and for the construction of buildings
 20 authorized under §22-3-1201.

21

22 19-5-974. Higher Education Projects Development Fund.

23 There is hereby established on the books of the State Treasurer, State
 24 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 25 "Higher Education Projects Development Fund". Such fund shall consist
 26 of proceeds from the sale of bonds as issued by the Arkansas Development
 27 Finance Authority and revenues derived from any project financed under
 28 the "Arkansas College Savings Bond Act of 1989", in amounts or portions
 29 as set forth in the resolution or trust indenture authorizing or
 30 securing such bonds, there to be used to provide for the development of
 31 projects at state institutions of higher education and the payment of
 32 project costs and expenses of the issuance of bonds, as set out in the
 33 "Arkansas College Savings Bond Act of 1989".

34

35 19-5-975. College Savings Bond Fund.

1 There is hereby established on the books of the State Treasurer, State
 2 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 3 "College Savings Bond Fund". Such fund shall consist of proceeds from
 4 the sale of bonds as issued by the Arkansas Development Finance
 5 Authority and revenues derived from any project financed under the
 6 "Arkansas College Savings Bond Act of 1989", in amounts or portions as
 7 set forth in the resolution or trust indenture authorizing or securing
 8 such bonds; general revenues; and any other funds made available by the
 9 General Assembly; there to be used only to provide for payment of all or
 10 a part of debt service on bonds issued under the "Arkansas College
 11 Savings Bond Act of 1989", either at maturity or upon redemption prior
 12 to maturity, as administered by the State Treasurer.

13

14 19-5-976. College Savings Debt Service Reserve Fund.

15 There is hereby established on the books of the State Treasurer, State
 16 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 17 "College Savings Debt Service Reserve Fund". Such fund shall consist of
 18 proceeds from the sale of bonds as issued by the Arkansas Development
 19 Finance Authority and revenues derived from any project financed under
 20 the "Arkansas College Savings Bond Act of 1989", in amounts or portions
 21 as set forth in the resolution or trust indenture authorizing or
 22 securing such bonds; general revenues; and any other funds made
 23 available by the General Assembly; there to be used only to insure
 24 prompt payment of debt service on bonds issued under the "Arkansas
 25 College Savings Bond Act of 1989", either at maturity or upon redemption
 26 prior to maturity, as administered by the State Treasurer."

27

28 SECTION 11. MISCELLANEOUS FUNDS. Arkansas Code Title 19, Chapter 5,
 29 Subchapter 10, is hereby amended by adding the following new Sections:

30 "19-5-1036. Research Development Fund.

31 There is hereby established on the books of the State Treasurer, State
 32 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
 33 "Research Development Fund". Such fund shall consist of funds
 34 transferred from the Higher Education Building Maintenance Fund and any
 35 other monies as may be provided by the General Assembly, there to be

used for the administration and operations of the Arkansas Research Development Program, as set out in §6-61-801 et seq.

19-5-1037. Motion Picture Office Fund.

There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "Motion Picture Office Fund". Such fund shall consist of those funds transferred to it from the Miscellaneous Revolving Fund, which is reimbursed from the State Apportionment Fund in the amounts equal to one-half of one percent (1/2 of 1%) of the total amount of documented expenditures by motion picture production companies as provided for in §26-4-208, there to be used for all duties and functions of the Motion Picture Office and in lieu of general revenues in the event that assets accruing to the fund exceed the amount appropriated from general revenues for the Motion Picture Office, all within limitations as set out in §26-4-211.

19-5-1038. Revenue Local Tax Revolving Fund.

There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "Revenue Local Tax Revolving Fund". Such fund shall consist of income taxes or any taxes not otherwise prohibited by law levied by counties or municipalities and for which the collection and administration of such taxes are performed by the State, as authorized in §26-73-105, there to be transmitted at least quarterly in each state fiscal year to the local government levying the tax, all as set out in §§26-73-101 - 26-73-109.

19-5-1039. Rural Health Services Revolving Fund.

There is hereby established on the books of the State Treasurer, State Auditor, and Chief Fiscal Officer of the State a fund to be known as the "Rural Health Services Revolving Fund". Such fund shall consist of funds transferred from the General Improvement Fund or its successor or any other funds as may be made available by the General Assembly, there to be used to provide matching funds, on a fifty-fifty (50-50) cash basis up to a maximum of \$200,000 per applicant, for assisting in the

1 stabilizing of necessary medical services provided by county, local,
2 commercial or non-profit operations, all as administered by the
3 Department of Health as set out in §20-12-401 et seq.

4
5 19-5-1040. Rural Medical Clinic Revolving Loan Fund.

6 There is hereby established on the books of the State Treasurer, State
7 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
8 "Rural Medical Clinic Revolving Loan Fund". Such fund shall consist of
9 monies provided by law, there to be used solely and exclusively for the
10 making of loans by the Board of Finance, upon application therefor, for
11 the construction and equipping of rural medical clinics in rural areas
12 of this state, as defined in §20-12-202.

13
14 19-5-1041. City-County Tourist Facilities Aid Fund.

15 There is hereby established on the books of the State Treasurer, State
16 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
17 "City-County Tourist Facilities Aid Fund". Such fund shall consist of
18 monies deducted from the General Revenue Fund Account of the State
19 Apportionment Fund in such amounts necessary to meet the quarterly
20 payments to cities and counties that are parties to an agreement with
21 the state, entered into pursuant to §§14-171-204 - 14-171-210, there to
22 be administered by the State Board of Finance and disbursed by the State
23 Treasurer as set out in §14-171-201.

24
25 19-5-1042. Arkansas Water Resources Cost Share Revolving Fund.

26 There is hereby established on the books of the State Treasurer, State
27 Auditor, and Chief Fiscal Officer of the State a fund to be known as the
28 "Arkansas Water Resources Cost Share Revolving Fund". Such fund shall
29 consist of funds appropriated or otherwise secured for the purposes of
30 cost sharing with the federal government in local water resources
31 development projects and loan repayments to the fund, there to be used
32 to provide loans or grants to local governments for the purposes as
33 established in §15-22-801."

34

18 force at the beginning of the state fiscal year and that in the event that the
19 General Assembly extends beyond the sixty day limit, the effective date of
20 this act would not begin at that time creating confusion and not permitting
21 the agencies to implement those programs as approved by the General Assembly.
22 Therefore an emergency is hereby declared to exist and this act being
23 necessary for the immediate preservation of the public peace, health and
24 safety shall be in full force and effect from and after July 1, 1991.
