HOUSE RESOLUTION

7
8 TO AMEND THE HOUSE RULES TO CREATE THE HOUSE BUDGET
9 COMMITTEE.

11 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-EIGHTH GENERAL
12 ASSEMBLY OF THE STATE OF ARKANSAS:

13

14 SECTION 1. House Rule 51 is hereby amended to read as follows:
15 "51. The committees of the House of Representatives shall consist of
16 ten (10) standing committees and nine (9) select committees. The standing
17 committees shall be five (5) Class A committees and five (5) Class B
18 committees. The nine (9) select committees shall be four (4) joint select
19 committees and five (5) House select committees. The House standing, joint
20 select, select and special committees are as follows:

22 Class A Committees

23 Education

24 Judiciary

25 Public Health, Welfare and Labor

26 Public Transportation

27 Revenue and Taxation

28 Class B Committees

29 Aging and Legislative Affairs

30 Agriculture and Economic Development

31 City, County and Local Affairs

32 Insurance and Commerce

33 State Agencies and Governmental Affairs

34 JOINT SELECT COMMITTEES

35 Joint Committee on Children and Youth -- (to consist of five (5) members of

1 the House and five (5) members of the Senate, as provided by law).
2 (A.C.A. 10-3-1302 thru 10-3-1322)
3 Joint Committee on Energy -- (to consist of nine (9) members of the House and
4 five (5) members of the Senate, as provided by law). (A.C.A. 10-3-802
5 thru 10-3-822)

6 Joint Committee on Public Retirement and Social Security Programs -- (to
7 consist of ten (10) members of the House and seven (7) members of the
8 Senate, as provided by law). (A.C.A. 10-3-701 thru 10-3-703)
9 Joint Performance Review Committee -- (to consist of twenty (20) members of
10 the House and seven (7) members of the Senate, as provided by law).
11 (A.C.A. 10-3-901 thru 10-3-903)

12 **HOUSE SELECT COMMITTEES**

13 House Affairs Committee -- (to consist of no more than ten (10) members).

14 House Management Committee -- (to consist of no more than twenty (20)
15 members).

16 House Rules Committee -- (to consist of no more than seventeen (17) members).

17 House Committee on the Journal; Engrossed and Enrolled Bills -- (to consist of
18 not more than five (5) members).

19 House Budget Committee -- (to consist of twenty (20) members)."

20

21 SECTION 2. House Rule 52(d) is hereby amended to read as follows:
22 "(d) Members of the House Management Committee and the chairman and
23 vice-chairman of said committee, shall be appointed by the Speaker at his
24 discretion. Members of the House Rules Committee shall be appointed by the
25 Speaker, provided that once the House Rules Committee is established, the
26 Speaker shall appoint members only to fill vacancies on said committee. A
27 chairman and vice-chairman of the Rules Committee shall be selected based on
28 seniority on said committee. Members of the House Committee on the Journal;
29 Engrossed and Enrolled Bills shall consist of the Speaker of the House of
30 Representatives, the chairman of the House Management Committee, the chairman
31 of the House Rules Committee, and two (2) members of the House to be appointed
32 by the Speaker of the House; the chairman and vice-chairman of said committee
33 shall be named by the Speaker; and, the House Parliamentarian shall serve as
34 secretary and advisor to the committee. The House members of the Joint
35 Committee on Children and Youth (A.C.A. 10-3-1302 thru 10-3-1322) and the

1 chairman thereof, the House members of the Joint Committee on Energy (A.C.A.
2 10-3-802 thru 10-3-822) and the chairman thereof, the House members of the
3 Joint Committee on Public Retirement and Social Security Programs (A.C.A. 10-
4 3-701 thru 10-3-703) and the chairman thereof, shall be appointed by the
5 Speaker at his discretion, as provided by law. The members of the House Joint
6 Performance Review Committee (A.C.A. 10-3-901 thru 10-3-903) shall be
7 appointed by the Speaker of the House at his discretion, and the House co-
8 chairman shall be elected by the committee, as provided by law.

9 The House Budget Committee shall consist of five (5) House members
10 chosen from each congressional district as the same exists on January 1, 1991.
11 The selections shall be made by caucus of the House members residing within
12 each district. The term of office of the members shall be from sine die
13 adjournment of the regular session or June 1 of the odd numbered year,
14 whichever is earlier, until sine die adjournment of the next regular session
15 or June 1 of the next odd numbered year, whichever is earlier. The committee
16 shall select its chairman and its vice-chairman. Vacancies in House Budget
17 Committee membership shall be filled by caucus of the House members of the
18 congressional district from which the vacancy occurs."

19

20 SECTION 3. House Rule 63 is hereby amended to read as follows:

21 "(a) Committee on Rules.

22 (1) All proposed action touching the rules, joint rules, and order of
23 business shall be referred to the Committee on Rules.

24 (2) It shall always be in order to call up, for consideration, a report
25 from the Committee on Rules.

26 (3) The Committee on Rules shall present to the House reports
27 concerning rules, joint rules, and order of business on the third day after
28 convening of the House. The permanent rules shall be adopted by a majority of
29 the members and thereafter they may be changed only by a vote of sixty-seven
30 (67) members.

31 (4) The Speaker shall refer to the Committee on Rules, any matters
32 dealing with alcohol, cigarettes, tobacco, tobacco products, coin operated
33 amusement devices, vending machines, lobbying, pari-mutuel betting and similar
34 legislation.

35 (5) Rules of the preceding General Assembly shall automatically be

1 adopted as temporary rules of the current assembly and may be amended or
2 suspended by a majority vote of the membership.

3 (b) House Budget Committee. All appropriation bills coming before the
4 House after adjournment sine die of the 1991 Regular Session or June 1, 1991,
5 whichever is earlier, shall be assigned to and considered by the House Budget
6 Committee."
