## 7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR PUBLIC WASTE WATER  
9 TREATMENT FACILITIES FOR THE ARKANSAS DEVELOPMENT FINANCE  
10 AUTHORITY WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO  
11 THOSE FUNDS APPROPRIATED BY ACT 36 OF THE FIRST  
12 EXTRAORDINARY SESSION OF 1989, FOR THE FISCAL YEAR ENDING  
13 JUNE 30, 1991; AND FOR OTHER PURPOSES."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16

17 SECTION 1. APPROPRIATIONS - TRANSFER. There is hereby appropriated, to  
18 the Arkansas Development Finance Authority, to be payable from the General  
19 Improvement Fund or its successor fund or fund accounts, for a fund transfer  
20 to the Construction Grants Revolving Loan Fund of the Arkansas Development  
21 Finance Authority which shall be supplemental and in addition to those funds  
22 appropriated in Section 4 of Act 36 of the First Extraordinary Session of  
23 1989, for the remainder of the fiscal year ending June 30, 1991, the  
24 following:

31 SECTION 2. APPROPRIATIONS - GOVERNMENTAL CONSTRUCTION GRANT LOANS.  
32 There is hereby appropriated, to the Arkansas Development Finance Authority,  
33 to be payable from the Construction Grant Revolving Loan Fund, for providing  
34 grants to municipalities for the construction of sewage treatment facilities  
35 of the Arkansas Development Finance Authority which shall be supplemental and

1 in addition to those funds appropriated in Section 5 of Act 36 of the First  
2 Extraordinary Session of 1989, for the remainder of the fiscal year ending  
3 June 30, 1991, the following:

9 SECTION 3. Pursuant to actions of the Seventy-Eighth General Assembly,  
10 any appropriations made payable from the Construction Grants Revolving Loan  
11 Fund are hereby deemed to be payable from the Construction Assistance  
12 Revolving Loan Fund.

13

14 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
15 authorized by this Act shall be limited to the appropriation for such agency  
16 and funds made available by law for the support of such appropriations; and  
17 the restrictions of the State Purchasing Law, the General Accounting and  
18 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
19 Procedures and Restrictions Act, or their successors, and other fiscal control  
20 laws of this State, where applicable, and regulations promulgated by the  
21 Department of Finance and Administration, as authorized by law, shall be  
22 strictly complied with in disbursement of said funds.

24 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
25 Assembly that any funds disbursed under the authority of the appropriations  
26 contained in this Act shall be in compliance with the stated reasons for which  
27 this Act was adopted, as evidenced by the Agency Requests, Executive  
28 Recommendations and Legislative Recommendations contained in the budget  
29 manuals prepared by the Department of Finance and Administration, letters, or  
30 summarized oral testimony in the official minutes of the Arkansas Legislative  
31 Council or Joint Budget Committee which relate to its passage and adoption.

32

33 SECTION 6. CODE. All provisions of this Act of a general and permanent  
34 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
35 Code Revision Commission shall incorporate the same in the Code.

2           SECTION 7. SEVERABILITY. If any provision of this Act or the  
3 application thereof to any person or circumstance is held invalid, such  
4 invalidity shall not affect other provisions or applications of the Act which  
5 can be given effect without the invalid provision or application, and to this  
6 end the provisions of this Act are declared to be severable.

7

8           SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict  
9 with this Act are hereby repealed.

10

11           SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the  
12 Seventy-Eighth General Assembly, that funds provided by the Seventy-Seventh  
13 General Assembly for the operations of the Arkansas Development Finance  
14 Authority are, due to unforeseen circumstances, insufficient for the Arkansas  
15 Development Finance Authority to continue to provide essential governmental  
16 services; that the provisions of this act will provide the necessary monies  
17 for the Arkansas Development Finance Authority to continue such services; and  
18 that a delay in the effective date of this Act could work irreparable harm  
19 upon the proper administration and provision of essential governmental  
20 programs. Therefore, an emergency is hereby declared to exist and this Act  
21 being necessary for the immediate preservation of the public peace, health and  
22 safety shall be in full force and effect from and after the date of its  
23 passage and approval.
