For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED 15-23-313(a)(1)
8 TO FURTHER DEFINE THAT PORTION OF THE SALINE RIVER
9 DESIGNATED AS A COMPONENT OF THE NATURAL AND SCENIC RIVERS
10 SYSTEM; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. Arkansas Code Annotated 15-23-313(a)(1) is amended to read
16 as follows:

17 "15-23-313. Specific designations - Prohibitions - Policy - Exemptions.
18 (a)(1) Notwithstanding any other provisions of this subchapter, the
19 following segments of rivers or streams are designated as components of the
20 Natural and Scenic Rivers System:

21 (A) Cossatot, from Gillham Reservoir (Section 8, Township 5
22 South, Range 30 West) upstream to headwaters near Baker Mountain (South Line
23 of Section 15, Township 3 South, Range 30 West);

24 (B) Strawberry, from the county line dividing Sharp and
25 Izard Counties (Section 12, Township 17 North, Range 7 West) upstream to
26 headwaters near Byron (North Line of Section 3, Township 19 North, Range 9
27 West);

28 (C) Saline, from confluence with the Ouachita River
29 (Section 9, Township 18 South, Range 10 West) upstream to headwaters in Saline
30 and Garland Counties, including all forks of the river in Saline County ;

31 (D) Little Missouri, from upper end of Lake Greeson (South
32 Line of Section 31, Township 5 South, Range 26 West) upstream to headwaters
33 South of Big Fork (Center of Section 32, Township 3 South, Range 28 West).

34 (2) The requirement of establishing an advisory committee or
35 developing a management plan as specified in §§15-23-308, 15-23-311, and

1 15-23-312 are waived for the segments of rivers or streams designated as
2 components of the Natural and Scenic Rivers System pursuant to this section.

3

4 SECTION 2. All provisions of this act of a general and permanent nature
5 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
6 Revision Commission shall incorporate the same in the Code.

7

8 SECTION 3. If any provision of this act or the application thereof to
9 any person or circumstance is held invalid, such invalidity shall not affect
10 other provisions or applications of the act which can be given effect without
11 the invalid provision or application, and to this end the provisions of this
12 act are declared to be severable.

13

14 SECTION 4. All laws and parts of laws in conflict with this act are
15 hereby repealed.
