# A Bill

**SENATE BILL 428**

## For An Act To Be Entitled

7 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
8 OPERATING EXPENSES FOR THE SMALL AND DISADVANTAGED  
9 BUSINESS PROGRAM OF THE ARKANSAS INDUSTRIAL DEVELOPMENT  
10 COMMISSION FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1993;  
11 AND FOR OTHER PURPOSES."

12  
13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14  
15 SECTION 1. REGULAR SALARIES - MINORITY BUSINESS DEVELOPMENT DIVISION -  
16 SMALL AND DISADVANTAGED BUSINESS PROGRAM. There is hereby established for the  
17 Arkansas Industrial Development Commission - Minority Business Development  
18 Division - Small and Disadvantaged Business Program for the 1991-93 biennium,  
19 the following maximum number of regular employees whose salaries shall be  
20 governed by the provisions of the Uniform Classification and Compensation Act  
21 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory  
22 thereto. Provided, however, that any position to which a specific maximum  
23 annual salary is set out herein in dollars, shall be exempt from the  
24 provisions of said Uniform Classification and Compensation Act. All persons  
25 occupying positions authorized herein are hereby governed by the provisions of  
26 the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-  
27 101), or its successor.

2 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the  
 3 Arkansas Industrial Development Commission, to be payable from the Department  
 4 of Industrial Development Fund Account, for personal services and operating  
 5 expenses of the Arkansas Industrial Development Commission - Minority Business  
 6 Development Division - Small and Disadvantaged Business Program, for the  
 7 biennial period ending June 30, 1993, the following:

22 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 23 authorized by this Act shall be limited to the appropriation for such agency  
 24 and funds made available by law for the support of such appropriations; and  
 25 the restrictions of the State Purchasing Law, the General Accounting and  
 26 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 27 Procedures and Restrictions Act, or their successors, and other fiscal control  
 28 laws of this State, where applicable, and regulations promulgated by the  
 29 Department of Finance and Administration, as authorized by law, shall be  
 30 strictly complied with in disbursement of said funds.

32 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General  
 33 Assembly that any funds disbursed under the authority of the appropriations  
 34 contained in this Act shall be in compliance with the stated reasons for which  
 35 this Act was adopted, as evidenced by the Agency Requests, Executive  
 36 Recommendations and Legislative Recommendations contained in the budget

1 manuals prepared by the Department of Finance and Administration, letters, or  
2 summarized oral testimony in the official minutes of the Arkansas Legislative  
3 Council or Joint Budget Committee which relate to its passage and adoption.

5 SECTION 5. CODE. All provisions of this Act of a general and permanent  
6 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
7 Code Revision Commission shall incorporate the same in the Code.

8

9 SECTION 6. SEVERABILITY. If any provision of this Act or the  
10 application thereof to any person or circumstance is held invalid, such  
11 invalidity shall not affect other provisions or applications of the Act which  
12 can be given effect without the invalid provision or application, and to this  
13 end the provisions of this Act are declared to be severable.

14

15 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict  
16 with this Act are hereby repealed.

17

18 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the  
19 Seventy-Eighth General Assembly, that the Constitution of the State of  
20 Arkansas prohibits the appropriation of funds for more than a two (2) year  
21 period; that the effectiveness of this Act on July 1, 1991 is essential to the  
22 operation of the agency for which the appropriations in this Act are provided,  
23 and that in the event of an extension of the Regular Session, the delay in the  
24 effective date of this Act beyond July 1, 1991 could work irreparable harm  
25 upon the proper administration and provision of essential governmental  
26 programs. Therefore, an emergency is hereby declared to exist and this Act  
27 being necessary for the immediate preservation of the public peace, health and  
28 safety shall be in full force and effect from and after July 1, 1991.
