# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE §27-35-203 (i) (1) TO PROVIDE  
9 THAT ALL VEHICLES WITH FIVE (5) AXLES LICENSED AS NATURAL  
10 RESOURCES VEHICLES SHALL BE EXEMPT FROM THE FEDERAL BRIDGE  
11 FORMULA STATED IN ARKANSAS CODE §27-35-203 (e) WHEN  
12 OPERATED ON NON-INTERSTATE HIGHWAYS IN THE STATE; TO  
13 REPEAL ARKANSAS CODE §27-35-203 (g) (1) (A) RELATING TO THE  
14 EIGHT PERCENT (8%) VARIANCE FOR FIVE (5) AXLE VEHICLES  
15 HAULING UNFINISHED AND UNPROCESSED FARM PRODUCTS, FOREST  
16 PRODUCTS AND OTHER PRODUCTS OF THE SOIL; AND FOR OTHER  
17 PURPOSES."

18  
19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20  
21 SECTION 1. Subdivision (i) (1) of Arkansas Code §27-35-203 is hereby  
22 amended to read as follows:

23 "(i) (1) Vehicles, or combinations of vehicles, with five (5) axles  
24 hauling sand, gravel, rock, or crushed stone and vehicles or combinations of  
25 vehicles with five (5) axles hauling unfinished and unprocessed farm products,  
26 forest products or other products of the soil shall be exempt from the federal  
27 bridge formula found in subsection (e) of this section on non-interstate  
28 highways in this state."

29  
30 SECTION 2. All provisions of this act of general and permanent nature  
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
32 Revision Commission shall incorporate the same in the Code.

33  
34 SECTION 3. Severability. In the event any provision of this act is  
35 declared or adjudged to be invalid or unconstitutional, such declaration or

1 adjudication shall not affect the remaining portions of this act which can be  
2 given effect without the invalid or unconstitutional provision. The remaining  
3 portions of this act shall remain in full force and effect as if the portion  
4 declared or adjudged invalid or unconstitutional was not originally a part of  
5 the act.

7 SECTION 4. (a) Arkansas Code §27-35-203(g) (1) (A) is hereby repealed.

8 (b) All other laws and parts of laws in conflict with this act are  
9 hereby repealed.
