## 7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE ARKANSAS SENATE FOR THE  
10 BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR OTHER  
11 PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14

15 SECTION 1. REGULAR SALARIES-SENATE STAFF. There is hereby established  
16 for the Arkansas Senate for the 1991-93 biennium, the following maximum number  
17 of regular employees whose salaries shall be governed by the provisions of the  
18 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et  
19 seq.), or its successor, and all laws amendatory thereto. Provided, however,  
20 that any position to which a specific maximum annual salary is set out herein  
21 in dollars, shall be exempt from the provisions of said Uniform Classification  
22 and Compensation Act. All persons occupying positions authorized herein are  
23 hereby governed by the provisions of the Regular Salaries Procedures and  
24 Restrictions Act (Arkansas Code §21-5-101), or its successor.

4 SECTION 2. APPROPRIATIONS - STAFF. There is hereby appropriated, to the  
5 Arkansas Senate, to be payable from the State Central Services Fund, for  
6 personal services and operating expenses of the Arkansas Senate and the staff  
7 of the Arkansas Senate, for the biennial period ending June 30, 1993, the  
8 following:

17 SECTION 3. Any balances remaining on June 30, 1991 in the appropriations  
18 enacted in any act to defray the expenses of the Arkansas Senate of the  
19 Seventy-Eighth General Assembly may be carried forward into the fiscal year  
20 ending June 30, 1992, there to be made available for the same purposes. Any  
21 balance remaining on June 30, 1992 in the appropriation carried forward and in  
22 the appropriation provided by Section 2 herein for Maintenance and General  
23 Operations may be carried forward into the fiscal year ending June 30, 1993,  
24 there to be used for the same purposes.

25

26 SECTION 4. If the Senate Efficiency Committee and the Senate Fiscal  
27 Officer, subject to the approval of the Arkansas Senate, should determine that  
28 any item or portion thereof appropriated herein for a specific purpose is not  
29 needed for such purpose, the Senate Fiscal Officer may certify such fact to  
30 the State Auditor and the State Auditor shall cause transfer to be made from  
31 one item to another.

32

33 SECTION 6. The General Assembly hereby determines that the conducting of  
34 an Institute of Legislative Procedure, prior to the convening of Regular  
35 Sessions of the General Assembly, for the orientation of existing and

1 newly-elected members of the General Assembly on rules and legislative  
2 procedure and current fiscal conditions and other problems in state  
3 government, is essential to the proper functioning of each Regular Session of  
4 the General Assembly.

5       (a) The Arkansas Legislative Council and the Legislative Joint Auditing  
6 Committee shall cooperate in jointly sponsoring a biennial Institute of  
7 Legislative Procedure to carry out the aforementioned purposes. Members of  
8 the preceding General Assembly who have been re-elected to a new term in  
9 either house of the General Assembly, and newly-elected members of the House  
10 of Representatives and Arkansas Senate, shall be eligible to attend the  
11 biennial Institute of Legislative Procedure and shall be entitled, upon filing  
12 a claim therefor, to per diem in the amount fixed by law for payment to  
13 members of the General Assembly for attendance at legislative sessions per day  
14 for each day in attending the biennial Institute of Legislative Procedure, but  
15 in no event to exceed three (3) days per member, plus mileage in traveling  
16 from their place of residence to the biennial Institute of Legislative  
17 Procedure and return at the same rate of mileage authorized for official  
18 travel by state employees. Per diem and mileage for members of the General  
19 Assembly and newly-elected members of the General Assembly for attending the  
20 biennial Institute of Legislative Procedure shall be paid by their respective  
21 houses from the monies appropriated therefor.

22       (b) There is hereby appropriated, to be payable from the Constitutional  
23 Officers Fund, to the Arkansas Senate of the General Assembly of the State of  
24 Arkansas, to be used for payment of per diem and mileage of members of the  
25 Arkansas Senate who attend the biennial Institute of Legislative Procedure, to  
26 be held prior to the convening of the 1993 Regular Session of the General  
27 Assembly, the sum of .....\$ 3,750.

28

29       SECTION 7. The Senate Efficiency Committee may, at its direction and  
30 subject to the approval of the Arkansas Senate, employ Arkansas Senate  
31 employees and transfer or discharge any employee if it is deemed for the best  
32 interest of the Arkansas Senate.

33

34       SECTION 8. The Senate Chief of Staff shall be appointed and salary  
35 determined by the Senate Efficiency Committee, subject to the approval of the

1 Arkansas Senate, prior to July 1 of each fiscal year within the salary  
2 limitations as set out herein, and shall perform such duties as may be  
3 provided by the Rules of the Senate and by the Senate Efficiency Committee,  
4 subject to the approval of the Arkansas Senate. Appointment to and the salary  
5 to be paid to the positions of Senate Assistant Chief of Staff, Senate  
6 Information Director, and Administrative Assistant shall be made and  
7 determined, within the salary limitations as set out herein, by the Senate  
8 Efficiency Committee subject to the approval of the Arkansas Senate, after  
9 receiving recommendations from the Senate Chief of Staff. Each of the  
10 employees authorized by this Act shall serve at the pleasure of the Senate  
11 Efficiency Committee, subject to the approval of the Arkansas Senate. The  
12 Senate Fiscal Officer, the Senate Assistant Fiscal Officer, the Secretary of  
13 the Senate, and the Senate Properties Officer shall report directly to and be  
14 responsible directly to the Senate Efficiency Committee, subject to the  
15 approval of the Arkansas Senate.

16

17 SECTION 9. The Secretary of the Arkansas Senate, the Senate Fiscal  
18 Officer, the Senate Assistant Fiscal Officer and the Senate Properties Officer  
19 shall perform such duties during the Regular Session of the General Assembly  
20 and during the interim between the convening of Special Sessions and/or the  
21 next regular session of the General Assembly as may be provided by the rules  
22 of the Arkansas Senate or by the Arkansas Senate Efficiency Committee, subject  
23 to the approval of the Arkansas Senate.

24

25 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly  
26 that any funds disbursed under the authority of the appropriations contained  
27 in this Act shall be in compliance with the stated reasons for which this Act  
28 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
29 and Legislative Recommendations contained in the budget manuals prepared by  
30 the Department of Finance and Administration, letters, or summarized oral  
31 testimony in the official minutes of the Arkansas Legislative Council or Joint  
32 Budget Committee which relate to its passage and adoption.

33

34 SECTION 11. CODE. All provisions of this Act of a general and permanent  
35 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

1 Code Revision Commission shall incorporate the same in the Code.

2

3 SECTION 12. SEVERABILITY. If any provision of this Act or the  
4 application thereof to any person or circumstance is held invalid, such  
5 invalidity shall not affect other provisions or applications of the Act which  
6 can be given effect without the invalid provision or application, and to this  
7 end the provisions of this Act are declared to be severable.

8

9 SECTION 13. REPEALER. Arkansas Code §10-2-216(b) and all laws and parts  
10 of laws in conflict with this Act are hereby repealed.

11

12 SECTION 14. EMERGENCY CLAUSE. It is hereby found and determined by the  
13 Seventy-Eighth General Assembly, that the Constitution of the State of  
14 Arkansas prohibits the appropriation of funds for more than a two (2) year  
15 period; that the effectiveness of this Act on July 1, 1991 is essential to the  
16 operation of the agency for which the appropriations in this Act are provided,  
17 and that in the event of an extension of the Regular Session, the delay in the  
18 effective date of this Act beyond July 1, 1991 could work irreparable harm  
19 upon the proper administration and provision of essential governmental  
20 programs. Therefore, an emergency is hereby declared to exist and this Act  
21 being necessary for the immediate preservation of the public peace, health and  
22 safety shall be in full force and effect from and after July 1, 1991.
