For An Act To Be Entitled

8 "AN ACT TO INCREASE THE MOTOR VEHICLE INSPECTION FEE TO
9 PROVIDE ADDITIONAL REVENUES FOR PRISON CONSTRUCTION AND
10 INMATE CARE; AND FOR OTHER PURPOSES."

11

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

13

14 SECTION 1. Arkansas Code 27-32-112(b) is hereby amended to read as
15 follows:

16 "(b)(1) The fee for the inspection, including the issuance of the
17 certificate of approval, shall be five dollars (\$5.00), with the exception of
18 all motor trucks, trailers, semitrailers, and pole trailers in excess of gross
19 loaded weight of eight thousand pounds (8,000 lbs.).

20 (2) The fee for inspection, including the issuance of the certificate
21 of approval, for all motor trucks, trailers, semitrailers, and pole trailers
22 with a gross loaded weight in excess of eight thousand pounds (8,000 lbs.)
23 shall be under rules and regulations prescribed by the director but shall be
24 not less than five dollars (\$5.00) nor more than seventeen dollars and fifty
25 cents (\$17.50) per inspection."

27 SECTION 2. Arkansas Code 27-32-110(b)(3) is hereby amended to read as
28 follows:

29 "(3) The official certificates of inspection and approval shall be
30 obtained from the authority at a cost of *two dollars and twenty-five cents*
31 *(\$2.25)* per certificate. An additional fifty cents (\$.50) per certificate
32 shall be collected and paid in accordance with Section 27-32-116(a)."

33

34 SECTION 3. Arkansas Code 27-32-116(a) is hereby amended to read as
35 follows:

1 "(a) All fees, other than (i) amounts collected for the purchase of
2 certificates of inspection and (ii) the sum of fifty cents (\$.50) per
3 certificate of inspection, collected by the department under this chapter
4 shall be special revenues and shall be deposited in the State Treasury to the
5 credit of the State Police Fund to be used to defray the cost of administering
6 this chapter and for the support of the department as provided by law. The
7 sum of fifty cents (\$.50) per certificate of inspection identified in (ii)
8 above shall be paid to the County Reimbursement and Work Program Fund
9 established in 12-27-123."

10

11 SECTION 4. Subchapter 1 of Chapter 27 of Title 12 of the Arkansas Code
12 is hereby amended by inserting and additional section at the end thereof to
13 read as follows:

14 "12-27-123. County Reimbursement and Work Program Fund.

15 The fifty cents (\$.50) per certificate of the vehicle inspection which
16 is dispersed under 27-32-116(a) shall be remitted to the Department of
17 Correction to be deposited into a trust fund to be created by the Department
18 of Correction and to be entitled the County Reimbursement and Work Program
19 Fund. The monies in the County Reimbursement and Work Program Fund shall not
20 be general revenues nor revenues of the Department and shall not be subject to
21 the claims of the general creditors of the Department. Furthermore, the
22 monies deposited into the County Reimbursement and Work Program Fund shall be
23 used exclusively to reimburse counties for housing Department of Correction
24 inmates and as a fifty-fifty (50-50) match to counties participating in a work
25 program where persons are sentenced to county jails in lieu of the Arkansas
26 Department of Correction."

27

28 SECTION 5. All provisions of this Act of a general and permanent nature
29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
30 Revision Commission shall incorporate the same in the Code.

31

32 SECTION 6. If any provision of this Act or the application thereof to
33 any person or circumstance is held invalid, such invalidity shall not affect
34 other provisions or applications of the Act which can be given effect without
35 the invalid provision or application, and to this end the provisions of this
36 Act are declared to be severable.
