## For An Act To Be Entitled

7 "AN ACT TO AMEND SUBCHAPTER 4, CHAPTER 28, TITLE 4,  
8 ARKANSAS CODE ANNOTATED TO TRANSFER RESPONSIBILITIES  
9 REGARDING FILINGS OF CHARITABLE ORGANIZATIONS FROM THE  
10 SECRETARY OF STATE'S OFFICE TO THE ATTORNEY GENERAL'S  
11 OFFICE; AND FOR OTHER PURPOSES."

13

14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15

16 SECTION 1. Arkansas Code Annotated §4-28-401 is amended to read as  
17 follows:

18 "4-28-401. Definitions.

19 As used in this subchapter, unless the context otherwise requires:

20 (1) 'Person' means an individual, organization, group, association,  
21 partnership, corporation, or any combination of them;

22 (2) 'Charitable organization' means any benevolent,

23 philanthropic, patriotic, or eleemosynary person or one purporting to be such;  
24 and

25 (3) 'Contribution' means the promise or grant of any money or  
26 property of any kind or value."

27

28 SECTION 2. Arkansas Code Annotated §4-28-402 is amended to read as  
29 follows:

30 "4-28-402. Penalties.

31 Any person conducting a solicitation in violation of the provisions of  
32 this subchapter or filing false information pursuant to the provisions of this  
33 subchapter shall be punished by a fine not to exceed five hundred dollars  
34 (\$500) or by imprisonment for not more than six (6) months, or both, and every  
35 officer or agent of a charitable organization who authorizes or conducts the

1 solicitation shall be jointly and severally liable for the fine."

2

3 SECTION 3. Arkansas Code Annotated §4-28-403 is amended to read as  
4 follows:

5 "4-28-403. Injunctions.

6 Upon complaint of any person, or other information coming to the  
7 attention of the prosecuting attorney, that any charitable organization is  
8 violating or intends to violate the provisions of this subchapter, the  
9 prosecuting attorney may institute action in the proper chancery court to  
10 enjoin the soliciting of contributions by or on behalf of the charitable  
11 organization."

12

13 SECTION 4. Arkansas Code Annotated §4-28-404 is amended to read as  
14 follows:

15 "4-28-404. Prerequisite filings.

16 (a) (1) No charitable organization shall solicit contributions from  
17 persons in this state by any means whatsoever until the charitable  
18 organization has provided certain information concerning the solicitation as  
19 required by this subchapter on forms to be provided by the Attorney General  
20 and has filed the information with the Attorney General.

21 (2) The information so filed shall be available to the general  
22 public as a matter of public record.

23 (b) The forms containing such information shall be sworn to and shall  
24 include, but not be limited to:

25 (1) The identity of the charitable organization by or for whom  
26 the solicitation is to be conducted;

27 (2) The address of the charitable organization;

28 (3) The purpose for which the contributions solicited are to be  
29 used;

30 (4) The individual or officer who will have custody of the  
31 contributions;

32 (5) The individuals responsible for the distribution of the  
33 contributions;

34 (6) The period of time during which such solicitation is to be  
35 conducted;

1                   (7) A description of the method or methods of solicitation in  
2 such detail as may from time to time be determined by the Attorney General;

3                   (8) Whether the solicitation is to be conducted by voluntary  
4 unpaid solicitors, by paid solicitors, or both; and

5                   (9) If in whole or in part by paid solicitors, the name and  
6 address of each professional fund-raiser supplying the solicitors, the basis  
7 of payment, and the nature of the arrangement."

8

9                 SECTION 5. Arkansas Code Annotated §4-28-405 is amended to read as  
10 follows:

11                 "4-28-405. Reciprocal agreements with other states regarding required  
12 information.

13                 (a) The Attorney General may enter into reciprocal agreements with a  
14 like authority of any other state or states for the purpose of exchanging  
15 information made available to the Attorney General under this subchapter.

16                 (b) Pursuant to such agreements, the Attorney General may accept  
17 information filed by a charitable organization with another state in lieu of  
18 the information required to be filed by a charitable organization in  
19 accordance with the provisions of 4-28-404 if the information is substantially  
20 similar to the information required to be filed under 4-28-404."

21

22                 SECTION 6. Arkansas Code Annotated §4-28-406 is amended to read as  
23 follows:

24                 "4-28-406. Reports.

25                 (a) On or before March 31 of each year, every charitable organization  
26 subject to the provisions of this subchapter which has received contributions  
27 during the previous calendar year shall file the following information in the  
28 manner hereinbefore provided and on forms to be provided by the Attorney  
29 General:

30                   (1) The gross amount of the contributions pledged or collected;

31

32                   (2) The amount given or to be given to the charitable purpose  
33 represented;

34                   (3) The aggregate amount paid and to be paid for the expense of  
35 the solicitation; and

1                   (4) The aggregate amount paid to and to be paid to professional  
2 fund-raisers and solicitors.

3                   (b) A charitable organization which maintains its books on other than a  
4 calendar year basis may, upon application to the Attorney General, be  
5 permitted to file its report within ninety (90) days after the close of its  
6 fiscal year.

7                   (c) In addition, the Attorney General may require that within ninety  
8 (90) days after the close of any special period of solicitation, the  
9 charitable organization conducting the solicitation shall file a special  
10 report of the information specified in this section for the special period of  
11 solicitation."

12

13                 SECTION 7. Arkansas Code Annotated §4-28-407 is amended to read as  
14 follows:

15                 "4-28-407. Records - Exemptions.

16                 (a) (1) Every charitable organization subject to the provisions of this  
17 subchapter shall keep a full and true record in such form as will enable the  
18 charitable organization accurately to provide the information required by this  
19 subchapter.

20                 (2) All records required hereunder shall be open to inspection at  
21 all times by the Attorney General and upon demand shall be presented to the  
22 Attorney General for inspection.

23                 (b) (1) This subchapter shall not apply to any solicitation made by the  
24 members of a charitable organization where the contributions are solicited  
25 solely from persons who are members thereof at the time of the solicitation  
26 nor shall this subchapter apply to solicitations made solely for church,  
27 missionary, or religious purposes.

28                 (2) (A) This subchapter shall not apply to any charitable  
29 organization which does not intend to solicit and receive, and does not  
30 actually receive, contributions in excess of one thousand dollars (\$1,000)  
31 during a calendar year if all of its functions, including its fund-raising  
32 functions, are carried on by persons who are unpaid for their services, and  
33 provided that no part of its assets or income inures to the benefit of or is  
34 paid to any officer or member.

35                 (B) However, if the gross contributions received by the

1 charitable organization during any calendar year shall be in excess of one  
2 thousand dollars (\$1,000), it shall, within thirty (30) days after the date it  
3 shall have received total contributions in excess of one thousand dollars  
4 (\$1,000), register with and report to the Attorney General as required by this  
5 subchapter."

6

7 SECTION 8. Arkansas Code Annotated §4-28-408 is amended to read as  
8 follows:

9 "4-28-408. Nonresident organizations - Service of process.

10 (a) A nonresident charitable organization desiring to solicit funds  
11 within the State of Arkansas shall file with the information required in  
12 4-28-404 an irrevocable written consent that in suits, proceedings, and  
13 actions growing out of the violation of any provision of this subchapter, or  
14 as a result of any activities conducted within this state giving rise to a  
15 cause of action, service on the Attorney General shall be as valid and binding  
16 as if due service had been made on the said charitable organization.

17 (b) In case any process or pleadings are served upon the Attorney  
18 General, they shall be in duplicate, one (1) copy of which shall be filed in  
19 the office of the Attorney General, and the other immediately forwarded by the  
20 Attorney General by registered or certified mail to the principal office or  
21 place of business of the nonresident charitable organization. Any service so  
22 had on the Attorney General shall be returnable in not less than thirty (30)  
23 days."

24

25 SECTION 9. Arkansas Code Annotated §4-28-409 is amended to read as  
26 follows:

27 "4-28-409. City ordinances provisionally authorized.

28 Nothing contained in the provisions of this subchapter shall prohibit  
29 any city in the State of Arkansas from enacting ordinances regulating a  
30 solicitation of contributions within the limits of the city, unless the  
31 charitable organization subject to the provisions of this subchapter complies  
32 with the filing, reporting, and registration requirements thereof."

33

34 SECTION 10. All provisions of this act of a general and permanent  
35 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

1 Code Revision Commission shall incorporate the same in the Code.

2

3 SECTION 11. If any provision of this act or the application thereof to  
4 any person or circumstance is held invalid, such invalidity shall not affect  
5 other provisions or applications of the act which can be given effect without  
6 the invalid provision or application, and to this end the provisions of this  
7 act are declared to be severable.

8

9 SECTION 12. All laws and parts of laws in conflict with this act are  
10 hereby repealed.
