7 **For An Act To Be Entitled**

8 "AN ACT TO MAKE AN APPROPRIATION TO THE DEPARTMENT OF
9 PARKS AND TOURISM FOR VARIOUS CONSTRUCTION, ACQUISITIONS,
10 RENOVATION AND EQUIPPING PROJECTS; AND FOR OTHER
11 PURPOSES."

12

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14

15 SECTION 1. APPROPRIATIONS - GENERAL IMPROVEMENT. There is hereby
16 appropriated, to the Department of Parks and Tourism, to be payable from the
17 General Improvement Fund or its successor fund or fund accounts, the
18 following:

19

20 (A) For various construction projects and associated costs at Beaver
21 Lake State Park, the sum of \$1,140,785.

22

23 (B) For the construction of a handicapped accessible mineral processing
24 pavilion at the Crater of Diamonds State Park, provided however, that no
25 improvements that could not be relocated shall be built, the sum of.. \$160,437.

26

27 (C) For major maintenance, renovation and repair at DeGray, Petit Jean,
28 Lake Chicot, Village Creek, Lake Dardanelle and Lake Catherine State Parks,
29 the sum of \$527,560.

30

31 (D) For various construction, renovation, repair and maintenance
32 projects at Old Washington State Park, the sum of \$417,000.

33

34 (E) For constructing, maintaining and equipping a Visitor
35 Information/Tourist Information Center and associated facilities at Bull

1 Shoals State Park, the sum of \$589,128.

4 (F) For major maintenance, renovation or repair, and equipment at Lake
5 Fort Smith State Park, the sum of \$187,980.

6

7 (G) For the construction of six rental cabins and equipment at
8 Crowley's Ridge State Park, the sum of \$596,508.

9

10 (H) For various construction projects and associated costs and
11 equipment at Old Davidsonville State Park, the sum of \$405,495.

12

13 (I) For the construction of water, gas and electric supply lines and
14 associated costs at Mount Magazine State Park, the sum of \$1,117,065.

15

16 (J) For construction and associated costs of Phase I development at
17 Cossatot River State Park, the sum of \$604,478.

18

19 (K) For various major maintenance, renovation and repair and
20 acquisition of land at Powhatan Courthouse State Park, the sum of ... \$64,762.

21

22 (L) For renovation and repairs of the lodge heating and air
23 conditioning system at Queen Wilhemina State Park, the sum of \$147,885.

24

25 (M) For various construction, major maintenance, renovation, repair and
26 purchase of equipment at Arkansas Post Museum, the sum of \$110,652.

27

28 (N) For providing FUN (Facilities for Underdeveloped Neighborhoods)
29 Park grants to small communities and rural areas, the sum of \$1,000,000.

30

31 (O) For major maintenance, renovation, dry docking and development of
32 the Ferry Museum at Moro Bay State Park, the sum of \$94,000.

33

34 (P) For constructing, equipping and associated costs related to expand
35 the Visitor Information Center and construction of employee housing for
36 uniform personnel at Lake Charles State Park, the sum of \$106,700.

2 (Q) For constructing, equipping and associated costs of a Maintenance
3 Building and Maintenance Shed at Lake Charles State Park , the sum of
4 \$121,275.

5

6 (R) For constructing, equipping and associated costs of an enclosed
7 swimming pool, hot tub and sauna at Queen Wilhemina State Park, the sum of
8 \$290,525.

9

10 (S) *For construction of a twenty-boat slip covered marina and service
11 building, utilities, furnishings and equipment, rip rap one quarter mile of
12 eroded river bank, architect/engineering fee and contingency at Moro Bay State
13 Park, the sum of \$354,684.*

14

15 (T) *For construction of a Collections Management facility, an equipment
16 building, land acquisition and other associated costs at the Scott Agriculture
17 Museum, the sum of \$157,000.*

18

19 SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
20 obligations otherwise incurred in relation to the project or projects
21 described herein in excess of the State Treasury funds actually available
22 therefor as provided by law. Provided, however, that institutions and
23 agencies listed herein shall have the authority to accept and use grants and
24 donations including Federal funds, and to use its unobligated cash income or
25 funds, or both available to it, for the purpose of supplementing the State
26 Treasury funds for financing the entire costs of the project or projects
27 enumerated herein. Provided further, that the appropriations and funds
28 otherwise provided by the General Assembly for Maintenance and General
29 Operations of the agency or institutions receiving appropriation herein shall
30 not be used for any of the purposes as appropriated in this Act.

31 (B) The restrictions of any applicable provisions of the State
32 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
33 Revenue Stabilization Law and any other applicable fiscal control laws of this
34 State and regulations promulgated by the Department of Finance and
35 Administration, as authorized by law, shall be strictly complied with in
36 disbursement of any funds provided by this Act unless specifically provided

1 otherwise by law.

2

3 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
4 Assembly that any funds disbursed under the authority of the appropriations
5 contained in this Act shall be in compliance with the stated reasons for which
6 this Act was adopted, as evidenced by the Agency Requests, Executive
7 Recommendations and Legislative Recommendations contained in the budget
8 manuals prepared by the Department of Finance and Administration, letters, or
9 summarized oral testimony in the official minutes of the Arkansas Legislative
10 Council or Joint Budget Committee which relate to its passage and adoption.

11

12 SECTION 4. CODE. All provisions of this Act of a general and permanent
13 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
14 Code Revision Commission shall incorporate the same in the Code.

15

16 SECTION 5. SEVERABILITY. If any provision of this Act or the
17 application thereof to any person or circumstance is held invalid, such
18 invalidity shall not affect other provisions or applications of the Act which
19 can be given effect without the invalid provision or application, and to this
20 end the provisions of this Act are declared to be severable.

21

22 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
23 with this Act are hereby repealed.

24

25 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
26 Seventy-Eighth General Assembly, that the Constitution of the State of
27 Arkansas prohibits the appropriation of funds for more than a two (2) year
28 period; that the effectiveness of this Act on July 1, 1991 is essential to the
29 operation of the agency for which the appropriations in this Act are provided,
30 and that in the event of an extension of the Regular Session, the delay in the
31 effective date of this Act beyond July 1, 1991 could work irreparable harm
32 upon the proper administration and provision of essential governmental
33 programs. Therefore, an emergency is hereby declared to exist and this Act
34 being necessary for the immediate preservation of the public peace, health and
35 safety shall be in full force and effect from and after July 1, 1991.
