**HOUSE BILL**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE §16-17-108(kk) FOR THE  
9 PURPOSE OF CORRECTING THE PROVISION FOR SALARIES OF THE  
10 MUNICIPAL COURT OF FORDYCE, ARKANSAS; AND FOR OTHER  
11 PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. Arkansas Code §16-17-108(kk) is amended to read as follows:

16 "(kk) The Fordyce Municipal Court Judge shall receive an annual salary  
17 of not less than twelve thousand dollars (\$12,000) nor more than twenty-four  
18 thousand dollars (\$24,000), and the clerks of said court shall receive an  
19 annual salary of not less than seven thousand dollars (\$7,000) nor more than  
20 fourteen thousand dollars (\$14,000), as may be determined by the Fordyce City  
21 Council and the Dallas County Quorum Court, and said salaries shall be paid by  
22 the City of Fordyce and Dallas County in equal monthly installments."

23  
24 SECTION 2. All provisions of this act of a general and permanent nature  
25 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
26 Revision Commission shall incorporate the same in the Code.

27  
28 SECTION 3. If any provision of this act or the application thereof to  
29 any person or circumstance is held invalid, such invalidity shall not affect  
30 other provisions or applications of the act which can be given effect without  
31 the invalid provision or application, and to this end the provisions of this  
32 act are declared to be severable.

34 SECTION 4. All laws and parts of laws in conflict with this act are  
35 hereby repealed.

SECTION 5. EMERGENCY. It is hereby found and determined by the General Assembly of the State of Arkansas that Act 982 of 1991 inadvertently failed to set a salary range for the municipal court judge and clerk of the Fordyce municipal court, but rather set a specified salary which is not reflective of the salary the judge and clerk are currently paid and is not reflective of the salary approved by the Fordyce City Council and the Dallas County Quorum Court. Therefore, an emergency is hereby declared to exist and this act being necessary for the immediate preservation of the public peace, health, and safety, shall be in full force and effect from and after its passage and approval.
