## For An Act To Be Entitled

7  
8 "AN ACT TO AMEND ARK. CODE ANN. §§6-67-101 AND 6-67-110 TO  
9 DELETE REFERENCES TO WHITE PERSONS; AND FOR OTHER  
10 PURPOSES."

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

13

14 SECTION 1. Ark. Code Ann. §6-67-101 is hereby amended to read as  
15 follows:

16 "6-67-101. Establishment and purpose.

17 For the purpose of providing for the preparation and training of all  
18 persons, both male and female, citizens of the state desiring to teach in the  
19 state, there is established and maintained as in this chapter provided an  
20 institution to be known as the "University of Central Arkansas," in which  
21 instruction shall be given in the various branches provided for in the public  
22 schools of Arkansas and in all subjects needed to equip teachers in the public  
23 schools and in all fundamental laws of the United States and of the State of  
24 Arkansas, regarding the rights and duties of citizens."

25

26 SECTION 2. Ark. Code Ann. §6-67-110 is hereby amended to read as  
27 follows:

28 "6-67-110. Scholarships.

29 (a) Each county in the state shall be entitled to one (1) scholarship  
30 for every twenty (20) teachers in the county, as shown by the latest report of  
31 the Department of Education, appointment to be made by the county school  
32 supervisor.

33 (b) (1) Should all the scholarships not be granted by the tenth day  
34 after the opening of the fall session of the school each year, the board of  
35 trustees shall have the power to make other appointments in order of

1 application.

2                   (2) The appointments are to be approved by the county school  
3 supervisor from whose county the application may come."

4

5                 SECTION 3. All public institutions of higher education in this state  
6 shall remove all references to white persons, blacks, coloreds, or Negroes  
7 from the charters, bylaws, or rules of the institutions.

8

9                 SECTION 4. All provisions of this act of a general and permanent nature  
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
11 Revision Commission shall incorporate the same in the Code.

12

13                SECTION 5. If any provision of this act or the application thereof to  
14 any person or circumstance is held invalid, such invalidity shall not affect  
15 other provisions or applications of the act which can be given effect without  
16 the invalid provision or application, and to this end the provisions of this  
17 act are declared to be severable.

18

19                SECTION 6. All laws and parts of laws in conflict with this act are  
20 hereby repealed.
