## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 16-17-108(iii) TO ESTABLISH  
9 THE MINIMUM AND MAXIMUM ANNUAL SALARY FOR THE MARIANNA  
10 MUNICIPAL COURT JUDGE; AND FOR OTHER PURPOSES."

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

13

14 SECTION 1. Arkansas Code 16-17-108(iii) is hereby amended to read as  
15 follows:

16 "(iii) Retroactive to January 1, 1992, the Marianna Municipal Court Judge  
17 shall receive an annual salary of not less than sixteen thousand dollars  
18 (\$16,000) nor more than twenty-seven thousand nine hundred dollars (\$27,900).  
19 The pro-rata share of the salary attributable to the City of Marianna shall be  
20 at least seven thousand dollars (\$7,000) but not more than twelve thousand six  
21 hundred dollars (\$12,600), and the pro-rata share of the salary attributable  
22 to the County of Lee shall be at least nine thousand dollars (\$9,000) but not  
23 more than fifteen thousand three hundred dollars (\$15,300). The County of Lee  
24 shall pay all of the salary, and the City of Marianna shall reimburse the  
25 County of Lee on a monthly basis the pro-rata share of the annual salary  
26 attributable to the City of Marianna."

27

28 SECTION 2. Arkansas Code 16-21-117(b) is hereby amended to read as  
29 follows:

30 "(b) (1) The Division A Judicial Districts are the First, Second, Third,  
31 Fourth, Sixth, Seventh, Eighth, Tenth, Eleventh-West, Twelfth, Fourteenth,  
32 Sixteenth, Eighteenth-East, Nineteenth, and Twentieth. The provisions of §16-  
33 87-106(b) shall not apply to the Eighteenth-East Judicial District.

34 (2) The Division B Judicial Districts are the Fifth, Ninth-East,  
35 Ninth-West, Eleventh-East, Thirteenth, Fifteenth, Seventeenth-East,

1 *Seventeenth-West, and Eighteenth-West."*

3 *SECTION 3. Arkansas Code 16-17-108(ffff) is hereby amended to read as*  
4 *follows:*

5 *"(ffff) The Prairie Grove Municipal Court Judge shall receive an annual*  
6 *salary of not less than eighteen thousand dollars (\$18,000) nor more than*  
7 *twenty-six thousand dollars (\$26,000), and the clerk shall receive an annual*  
8 *salary of not less than five thousand dollars (\$5,000) nor more than eighteen*  
9 *thousand dollars (\$18,000)."*

11 *SECTION 4. All provisions of this act of a general and permanent nature*  
12 *are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code*  
13 *Revision Commission shall incorporate the same in the Code.*

14

15 *SECTION 5. If any provision of this act or the application thereof to*  
16 *any person or circumstance is held invalid, such invalidity shall not affect*  
17 *other provisions or applications of the act which can be given effect without*  
18 *the invalid provision or application, and to this end the provisions of this*  
19 *act are declared to be severable.*

20

21 *SECTION 6. All laws and parts of laws in conflict with this act are*  
22 *hereby repealed.*

23

24 *SECTION 7. EMERGENCY. It is hereby found and determined by the General*  
25 *Assembly that the maximum annual salary for the Marianna municipal court judge*  
26 *is inadequate and should be increased as soon as possible and that this act*  
27 *will accomplish the same. Therefore, an emergency is hereby declared to exist*  
28 *and this act being necessary for the preservation of the public peace, health*  
29 *and safety shall be in full force and effect from and after its passage and*  
30 *approval.*
