7 **For An Act To Be Entitled**

8 "AN ACT TO REDESIGNATE THE EIGHTEENTH-WEST JUDICIAL
9 DISTRICT AS A DIVISION A JUDICIAL DISTRICT AS IT RELATES
10 TO PROSECUTING ATTORNEYS; AND FOR OTHER PURPOSES."

12 **Subtitle**

13 "AN ACT TO REDESIGNATE THE EIGHTEENTH-WEST JUDICIAL
14 DISTRICT AS A DIVISION A JUDICIAL DISTRICT AS IT RELATES
15 TO PROSECUTING ATTORNEYS."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 *SECTION 1.* *Retroactive to January 1, 1993 the Judicial District*
21 *Eighteenth-West Division B Prosecuting Attorney shall be reclassified as a*
22 *Division A Judicial District Prosecuting Attorney.*

27 *SECTION 2.* All provisions of this act of a general and permanent
28 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
29 Code Revision Commission shall incorporate the same in the Code.

31 *SECTION 3.* If any provision of this act or the application thereof to
32 any person or circumstance is held invalid, such invalidity shall not affect
33 other provisions or applications of the act which can be given effect without
34 the invalid provision or application, and to this end the provisions of this
35 act are declared to be severable.

2 SECTION 4. All laws and parts of laws in conflict with this act are
3 hereby repealed.

4

5 *SECTION 5. EMERGENCY. It is hereby found and determined by the General*
6 *Assembly that the Prosecuting Attorney of the Eighteenth-West Judicial*
7 *District in this state is inadequately compensated; that the caseload of the*
8 *circuit has increased substantially; and that this act is indispensable to*
9 *assure the efficient administration of justice in this circuit. Therefore an*
10 *emergency is hereby declared to exist and this act, being necessary for the*
11 *immediate preservation of the public peace, health and safety, shall be in*
12 *full force and effective upon passage and approval.*
